Thank you for your interest in initiating a service learning project. Your effort and actions will go a long way in benefiting the community.

Some examples of service learning projects you can initiate are:

- 1) Advocacy Service: Link up with an organisation to continue advocating for a cause after your Learning Alliance Beyond Borders (LABB) experience
- 2) Direct Service: Organising a programme for seniors at an eldercare centre
- 3) Indirect Service: Plan and conduct a food donation drive

Depending on the nature of the project, it can be done individually or in a **planning committee group of a maximum of 5 students.**

**Please read the following criteria and project deadlines before filling in the form.**

**Criteria of Student-Initiated Service Learning Projects**

- Students research and identify a specific community need
- Student research on a Voluntary Welfare Organisation (VWO) to collaborate with and liaise with them directly.
- Student manages all aspects of the project: finances, logistics, programmes etc., under the guidance of teacher mentor

**Criteria for students who initiate Student-Initiated Service Learning Projects**

**Members**

Individual or in a planning committee group (exco) of a maximum of 5 students.

Applicable mainly to Sec 3 and 4 students. However, Sec 2 students who are interested may apply as well.

**Co-curriculum**

At least 80% attendance in CCA in the past two years (75% benchmark - MOE)

Served in at least 1 service project or attended a service-learning programme in SST

### **Characteristics of a Service Learning Project Proposal**


- should have well-formulated and clearly stated goals and plans
- should have sufficient (but not excessive) detail
- is of good writing style
- accuracy: spelling, grammar, choice of words, punctuation
- clarity: each sentence, paragraph, and section should make a clear statement
- coherence: each sentence, paragraph, and section should follow a logical progression
- adherence to the required format, citation style
- can be used as a working document to guide project planning
- can be used as a reference resource for future service learning projects

## **1. SERVICE LEARNING CYCLE**

The Service Learning Cycle will be used to guide your Service Learning process. In this proposal, we will be focusing on the investigation and preparation stages.



## STAGE 1: INVESTIGATION

To begin, the Investigation stage involves **gathering information** about the issue of interest and **subsequent analysis to identify a community need and uncover possible causes**.

Next, research **pre-existing actions by organisations** to help your team decide how to plan a service for the chosen community need.
