Assembly Bill that has to do with layoff protections for classified employees. Any classified employee can be released with 60-days notice, but now with the new bill the layoff notification has to happen similar to certificated staff which is a March 15th deadline. Our HR department has to significantly move up our date for when employees need to be notified of position opportunities

- o Relevance is that PTO pays for some of the grant for some of the employees
- Contracted employees that we have are Librarian and IAs
- We'll have to know by January, versus normally later in the year, whether we'll need to fund the roles for the next year.
- Wage increases are also being negotiated at the time, to consider for the cost. Avg 3-8%
