# 3 Massachusetts Bills to help stop abductions of immigrants

### -The Safe Communities Act (SCA) (H.2580/S.1681)

The Act would limit voluntary police and court involvement in civil immigration matters, protect basic rights, and keep law enforcement agencies focused on public safety. <u>Info sheet here.</u>

### -The Immigrant Legal Defense Act (ILD) (H.1954/S.1127)

The Act would create a funded statewide program to provide no-cost immigration legal defense to immigrants in Massachusetts who are at imminent risk of deportation, especially those held in federal immigration detention.

### -The Dignity Not Deportations Act (DND) (<u>H.1588</u>/ <u>S.1122</u>)

The Act would prohibit contracts between ICE and MA law enforcement and would prohibit MA sheriffs from renting beds in our county jails to ICE for use as detention beds.
