### GENERAL INFORMATION FOR FILLING OUT THE ENTRY FORMS:

Only the UKC Approved Nosework Entry Forms will be accepted.

A and B SECTIONS: Exhibitors must specify on the entry form if they are going to compete in the A or B section for each search. Both sections will have the same search.

- 'A' Section is for teams that are completely new to the sport (have not earned a NW title).
- 'B' Section is for all other teams listed below:
  - Have earned an equivalent title in another Nosework organization, such as NACSW.
  - Are a licensed or professional dog trainer, Nosework instructor, or a person licensed to officiate in Nosework any organization

Photography: No Show Photographer will be available for the trial.

Crating: This is an outdoor only trial with outdoor only crating space.

Move-Up Policy: Move-ups will be allowed at this trial. Move ups MUST be turned in no later than ½ hour after the end of the first trial.

Substitution Policy: No substitution of dogs will be allowed.

Awards and Prizes: Placement ribbons will be provided for 1-4 placements in each class. Blue qualifying ribbons will be awarded to all dogs receiving a qualifying score. There will also be title ribbons.

# **NOTICE TO EXHIBITORS:**

- 1. Dogs MUST be UKC registered. A UKC Registration Number, a Limited Privilege or Temporary Listing number is required with your entry in order to participate. For information on UKC registration go to www.ukcdogs.com.
- 2. A UKC PT or NACSW ORT is required for entry in a UKC element title trial for the level/odor entered. A copy of an ORT needs to be sent with the entry.
- 3. Handlers are only allowed to run 1 dog per element level or PT level.
- 4. All events are held under the Rules and Regulations of the United Kennel Club, Inc.
- 5. Absolutely no alcoholic beverages or illegal drugs will be allowed on the grounds.
- 6. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- 7. Exhibitors and dog owners are expected and required to clean up after their own dogs.
  - 8. Neither ETC, nor the United Kennel Club, Inc. is responsible for theft, loss, accident or injury to any dog, person or property at any of their events. Aggressive behavior by dogs shall not be tolerated at UKC events. See Waiver on Entry Form.
  - 9. UKC will vigorously support any motel that files a complaint about exhibitors who fail to keep their dogs quiet or to clean up after them. In order that the bad conduct of a few exhibitors does not spoil it for the majority of responsible exhibitors, UKC will take strong disciplinary action against any offenders.
