



MPC-CB Certified Productivity Specialist (CPS) are required to fulfill their **Continuous Productivity Development (CPD)** hours in order to retain their certification.

- CPS need to maintain a minimum of **90 CPD hours in preceding 3 years or 30 CPD hours per year.**
- At least **25 hours** must be **Structured Learning**, with a minimum of 14 structured learning hours annually; **25 hours** of **unstructured learning and 40 hours of implementing productivity improvement projects.**
- Activities recognized as CPD include but are not limited to: A. Attending courses, conferences, seminars and workshops.; B. Participating in technical discussion meetings or similar events; C. Making technical presentations in classes, symposiums or similar events; D. Teaching unrepeated structured courses.
