The constitutionality of the search was questioned and ultimately the Supreme Court faced the task of establishing parameters for searches and seizures in schools. This brought up questions of whether students in school have the same rights under the 4th Amendment as adults? Does "probable cause" have to be established for the search of a student in school, or is "reasonable cause" enough? In this case, the court sided with the school.
