I know that you are committed to creating a food and farming system that works for all of us and protects our climate. I am reaching out now because the Trump Administration is planning to hold a confirmation hearing for Agriculture Secretary Nominee Brooke Rollins before the end of the month.

Ms. Rollins is the co-founder and Chief Executive Officer of the America First Policy Institute (AFPI), which has been described as the "second Trump administration in waiting." Rollins' agricultural policy record is minimal and her qualifications for the appointment are unclear. We understand that you are juggling many requests, but it is important to me that your office gets Rollins on record about her plans for the USDA at her confirmation hearing. As your constituent, I need to know how she plans to support small and midsize farms in our district, and if she is willing to create an Office of Small Farms within the U.S. government.

Many of the recommendations that the Equity Commission released last year require legislative action. The creation of an Office of Small Farms, however, is within the control of the next Secretary of Agriculture, and would help end the exclusion of small and midsize producers from accessing the USDA programs and services they need to survive and thrive.

We are in a time of climate crisis as life-threatening fires ravage our country, with farmers on the frontline. We need to support small and midsize producers in their efforts to help protect our climate and grow healthy foods now more than ever.

# <u>I urge you to ask Ms. Rollins these three questions at her confirmation hearing:</u>

- 1.) Under your leadership, how will USDA work to protect, support, and improve access for small farms, beginning and young farmers, and other farmers who have been historically underserved and faced discrimination?
- 2.) What qualifications do you believe are necessary in a candidate for Assistant Secretary for Civil Rights at USDA? How will you improve the discrimination complaints process at the Department?
- 3.) Will you create an office of Small Farms? If not, why not?

Thank you for your service, and for taking this action for all of us here in your state.

- How can an organizing conversation help us all process this political moment and prepare for action?
- What makes you most nervous about facilitating an organizing conversation? Does anyone in your breakout room share your concerns, or have tips?
- What excites you about using your scientific expertise and credentials to take political action? What gives you pause?
- How do you want to see scientists taking the lead in grassroots organizing right now?
- Why can scientists be particularly powerful changemakers? What do you think stops most scientists from taking political action or voting?
