- Name the superintendent as approving official and the board chairperson as hearing official for the hot lunch program.
- Allow the use of imprest funds to pay for employee expenses to attend meetings and functions in advance. The amount is \$5,000.
- Designate the Central MN Credit Union as official school depository and allow the superintendent and business manager to make investments in other institutions as they deem necessary and to allow electronic transfers.
- Set the mileage reimbursement rate at \$.50 per mile.
