

TERMS & CONDITIONS

KaanPhod Giveaway Contest ("CONTEST")

1. The Contest is organized by **Viacom 18 Media Private Limited ("Organizer")** and is open to all individual participant (the "**Participant(s)**") who, as on 19th May 2022:
 - (i) Are eighteen (18) years old or above in age,
 - (ii) shall have a valid proof Indian citizenship,
 - (iii) be permanent residents of India;
 - (iv) shall have a valid personal Instagram Account and/or Facebook Account and/or Twitter Accounts and/or are subscribers of Youtube account as per (v) below (the "**Personal Platform Account**"), (such account shall not be a group account, meme account, blogs, business accounts, brand accounts., bots, landing accounts, video accounts, etc.);
 - (v) are followers/subscribers/shall follow/subscribe the official KaanPhod social media handles, through their Personal Platform Accounts on the platforms of Facebook, Twitter, Instagram, Youtube (the "**Platforms**").
2. Participation by minors will be deemed as participation with the prior unconditional consent and knowledge of the Participant's parents/guardian. It is made abundantly and evidently clear that such Participants are participating in the Contest with the consent and assistance of their parents/guardians. Accordingly, the Participants shall be required provide all the necessary documents/proof as required by the Organizer upon its request in this regard. The validity of such proof shall be determined by Organizer at its own discretion. All the Terms and Conditions, Rules applicable on Participants/Shortlisted Participant/Winner shall deemed to also apply on the parents/guardians of such Participants/Shortlisted Participant/Winner.
3. The Contest shall commence on 19th May 2022 at 12:00 hours and shall conclude on 21st May 2022 at 18:00 hours or any other date or time as decided by the Organizer ("**Contest Period**"). Contest question might vary as per sole discretion of the Organizer. Contest Entry received after the Contest Period which includes end of each week for weekly contest, shall not be entertained and shall be considered ineligible for the Contest.
4. **Method of Participation:** To participate in the Contest, the Participant needs to make a valid Contest Entry during the Contest Period. The Contest Entry shall be made by doing all of the below mentioned acts:
 - (i) Completing the lyrics of the song and tagging one person they dedicate it to, as response to the question/ contest post uploaded by the Organizer during the Contest Period on either of the Platform(s) through their Personal Platform Accounts during the Contest Period;
 - (ii) Following the social media handles @kaanphod; and
 - (iii) Tagging atleast one person in their Contest Entry.

6. The Contest Entry shall not be in the form of photos, reels, videos in any form, stories/gifs or in any other format now known or hereinafter identified, if not specifically mentioned by the Organizer in its questions during the Contest Period.
7. By participating in the Contest, the Participant agree to be bound by any rules, regulations, guidelines, or policies ("**Rules**") associated with the Contest and agree to be bound by any decisions made by the Organizer, including any interpretations of such Rules by the Organizer.

8. **Specific Representations and Warranties**

Each Participant represents and warrants that;

- a. his/her participation is voluntary with his/her own free will and consent and is not forced to participate in this Contest;
- b. he/she, have read and accepted these Terms and Conditions.
- c. he/she has all the necessary permission/ approval to shoot and upload the Contest Entry.
- d. that he/she will comply with all the Rules associated with the Contest including but not limited to the Terms & Conditions mentioned herein and associated with the Prize (if applicable), and the Participant shall be liable for any breaches/violation/non-compliance.
- e. the Participant's Personal Platform Account and the Contest Entry is and will be in adherence and compliance to all the community guidelines, rules, terms, policy that have been published by Platform, along with any additions, modifications, renewals, revisions to the Platform terms that may come into existence in the future. The Organizer shall not be responsible or questioned or made liable for any acts of Platform, which may in addition to other acts, include termination, temporary or permanent suspension or take down of the Personal Platform Account and/or deletion/removal and/or take down of the Contest Entry.
- f. the Contest Entry provided by the Participant shall not defame/offend any person, sect, cast, etc. it shall not be obscene, vulgar, defaming, denigrating women, artist, celebrity or children, hurting religious sentiments, depicting violence, or against the public policy of India or/and the internal policies of the Organizer.

- h. that no license fee, royalties, charges, etc. are payable to any person/party/copyright society anywhere in the entire world, in relation to the Contest Entry and all rights are cleared.
- i. that the Contest Entry(s) shall be suitable for presentation in a public forum, in sole determination of the Organizer.
- j. Contest Entry shall not promote or advertise or tag any product(s), service(s) or brand(s), other than those brands whose mention/feature is necessary for participating in this Contest.
- k. Contest Entry(s) shall not contain content that depicts alcohol or tobacco or drugs or anything illegal. Contest Entry(s) shall not in any manner depict or encourage harm or injury to any person, party, animal.
- l. The Participant will be solely responsible and liable to ensure that any and all comments, replies, reposts, retweets, shares made to their respective Contest Entry by any third Party (except the Organizer), are in compliance and adherence with these Terms and Conditions that are applicable on the Contest Entry.
- m. If the Contest Entry submitted by the Participant features any third party other than the Participant, Participant shall ensure that the same is included and submitted with express approval of all such third party therein and the Participant shall be solely liable for submitting the same and any claim raised by such third parties or otherwise.

In the event of any violation/breach to any of the aforementioned representation and warranties or any other terms or condition, the Participant(s) shall at the discretion of the Organizer be disqualified from the Contest with immediate effect. The Organizer reserves the right to delete/remove any Contest Entry that violates these Terms and Conditions. By participating in the Contest, the Participant also agrees that they shall solely be liable for any and all action (criminal/civil) arising therefrom and shall also be liable to

indemnify the Organizer, for any loss, expense, liability, claim, dispute, disrepute, disruption caused to it, including attorney fees.

9. The Terms and Conditions of and in relation to this Contest as stated herein, is an electronic record in terms of Information Technology Act, 2000 ("Act") and rules thereunder as applicable and the amended provisions pertaining to electronic records in various statutes as amended by the Information Technology (Amendment) Act, 2008. This is a legal and binding agreement between the Participant and Organizer, that states the terms that govern the Participant's participation in the Contest. By making the Contest Entry, the Participant agrees to have read and understood the terms and conditions and hereby unconditionally consents, agrees and undertakes to abide, be bound by and adhere to the terms and conditions stated herein
10. **Selection of a Shortlisted Participant:** The Organizer shall evaluate and shortlist a 1 (one) contest entry (or any other minimum or maximum number as determined by the Organizer) on each Platforms during the Contest Period ("Shortlisted Contest Entries"), Participants of which submitted the Contest Entry on last come basis i.e was last to comment the correct answer at or by 18:00 hours on 20th May, as per the jury engaged by Organizer for this Contest, per its sole discretion and followed all rules of contest and which in the sole opinion of the Organizer are deemed suitable to win the Prize as per terms of the Contest. Each Platform 1 (one) participant will be selected, thereby total 4 (four) entries will be shortlisted. The Organizer selects and announces the shortlisted contest entries basis the Contest Entry submitted by the Participants at the end of the Contest Period or such time and date as determined by the Organizer at its sole discretion. The Participants who have submitted these Shortlisted Contest Entries may be selected for Verification as Shortlisted Participants ("**Shortlisted Participants**") by the Organizer, after which the shall at its sole discretion determined the final winners eligible for the Prize ("**Winners**"). The Organizer shall reach out to such Winner for further Verification of documents in-order check if they are eligible to be considered as Winner.
11. **Verification:** Before being considered and declared as a Winner, such Participant may be contacted anytime by Organizer either on their direct messages to the personal handles (used by the Participants to upload the Contest Entry)/ e-mail id/contact number provided or use such other mode of communication as may be determined by Organiser at its sole discretion. It is hereby clarified that information and documents shall pertain to such Participant only and not of any other person. Upon verification of the documents submitted by such Participant to the satisfaction of the Organizer, Organizer shall declare such Participant as the winner ("Winner"). Subject to timely co-operation by such Participant in verification, the Organizer directly communicate to the Winner of their win through email/direct message to the personal handles (used by the Participants to upload the Contest Entry) or via such other mode of communication as may be determined by Organiser.
12. For sake of clarity, no Participant will be considered as final Winner, unless when he/she has been specifically declared as a Winner by the Organizer, and not merely when he/she has been contacted by Organizer for verification or any other purpose.
13. Organizer reserves the right to disqualify a Participant/Shortlisted Participant/Winner at any time, if Organizers is of the opinion that the details and/or documents provided by

the Participant/Winner is not to the Organizer's satisfaction. No questions or communications shall be entertained in this regard for any reason.

14. Furthermore, the Organizer may at any time either forfeit the Prize or announce another Winner in place of the originally announced Winner if:
 - (i) the documents or details of the Participant/Winner is not correct in the opinion of the Organizers; or
 - (ii) documents so required are incomplete, misleading or untrue; or
 - (iii) the Winner/Shortlisted Participant and their respective guardians, parents do not have valid documents as may be required for the purpose of the Prize;
 - (iv) the Winner/Shortlisted Participant and respective guardians, do not sign the confidentiality, release letter or any other documents required, if any, by Organizers in relation to the Prize; or
 - (v) if the Winner do not approach the Organizer at the contact details provided by the Organizer, immediately upon such request by Organizer.
15. The Organizer reserves the right to disqualify the Participants immediately from the Contest if Participants have supplied untruthful, inaccurate, incorrect or misleading details and/or information, of any nature and/or have failed to abide by the Rules and/or are in breach of the terms hereof.
16. The Organizer may at its discretion publicly announce the name of the Winner.
17. If applicable, the parents/guardians of the minor Participant/Winner shall be required to sign the release form in the format required by the Organizer, for and on behalf of the Winner. Further, such Participant/Winner shall be required to submit to the Organizer, a document evidencing the fact that his/her participation in the Contest was approved by and was subject to the prior unconditional consent and knowledge of his/her, parents/guardian.
18. Mere participation in the Contest and making the Contest Entries does not entitle the Participants to win the Contest or the Prize. The selection process may vary and shall be as per the Organizer's sole discretion. The Participants /Winner/Shortlisted Participant and/or any third party shall have no right to question the process of selection. The Organizer may determine the correctness, quality, and validity of the Contest Entry and Organizer's assessment in this regard shall be final.
19. **PRIZE:** Each Winner will get a chance to win 1 (one) e-Amazon gift voucher worth approximately INR 2,500/- (Indian Rupees Two Thousand and Five Hundred Only) each.
 - a) Said e-Amazon gift voucher would be provided in form of a coupon code via email on the email address or via SMS or Whatsapp on the mobile number submitted by Participant and/or such other means of communication as deemed fit by Organizer determined at its sole discretion. Such e-Amazon gift voucher can be redeemed by the Winner on Amazon India's online shopping website for Amazon gift voucher, which vouchers shall be as per terms and conditions more particularly laid down in said e-voucher/ coupon code or as communicated by Amazon from time to time. Such coupon/ voucher shall be with an expiry date, as might be communicated by Amazon directly and/or on e-voucher/ coupon code and/or the Winner might be required to independently check same by visiting Amazon's website and/or application online while redeeming as applicable. 20. 21. All costs and expenses that are not specifically covered by the Organizer and not set out herein shall be solely borne by the Winner and no monies will be reimbursed by the Organizer and/or the Sponsor. Organizer takes no responsibility, liability to reimburse or compensate in any manner, towards the Winner's expenses including without limitation any expenses incurred towards travel, food, beverages and/or any other costs that may be incurred by the Winner to avail the Prize or to utilize the Prize. The Organizer shall not be responsible or liable in any manner whatsoever for any incident, accident that may occur during the course of the Winner's participation and/or otherwise in relation to the Contest or during the collection of the Prize.
22. The Winner hereby represent and warrant that they will comply with all the Rules associated with the Contest including but not limited to the Terms & Conditions mentioned herein and associated with the Prize, and that the Winner shall personally be liable for any breach thereto. Selection of a Participant as a Shortlisted Participant and/or Winner shall not relieve them of the Terms and Conditions applicable on Participants. For avoidance of doubt the Terms and Conditions shall be applicable on the Winner and Shortlisted Participants irrespective of the change in their status from a Participant to a Shortlisted Participant or Winner.
23. The Organizer shall not be responsible for any loss of entries for any reason, whatsoever including, due to or telephone lines, service providers, network breakdowns, computer service delays, interruptions, network failures or overloads, or for lost, misdirected or misplaced entries, or for entries received after the Contest Period or for any reasons beyond the control of the Organizer. Any dispute in connection to the same shall be settled between the Participant and the Service Provider without involving Organizer. The internet charges etc that may arise from participating in the Contest will be borne by the Participant. 24. 39. Under no circumstance, shall the Organizer and/or its parent, subsidiaries, associates, affiliates and group entities, and their respective directors, employees, officers, agents or representatives be liable to the Participants and/or the Winner or any third party for any lost profits or lost opportunities, indirect, special, consequential, incidental, or punitive damages whatsoever, even if the Organizer has been advised of the possibility of such damages. The Participants and the Winner specifically agree not to file in person/through any family member and/or any third party, any applications, criminal and/or civil proceedings in any courts or forum in India against the Organizer, its parents, subsidiaries, associates, affiliates and group entities, and their respective directors, employees, officers, agents or representatives to claim any damages or relief in connection with the Contest.
40. The Organizer may, at any time, at its discretion, cancel the Contest, change these Terms & Conditions, the Rules and/or the Prize mentioned herein, without prior notice, and the Participants/Winner acknowledge that such change shall be final, binding and irrevocable upon them.
41. The Participants/ Winner acknowledge that they will not hold the Organizer and/or any of its affiliates or agencies engaged by it with regard to this Contest liable for any loss of opportunity and/or monetary loss due to their participation in the Contest.
42. By participating in the Contest and accepting the Prize, the Winner waive all copyrights and any related rights on the Contest Entry. The Participant/ Winner consents to the Organizer's right to click photographs, take pictures, shoot audio-visuals, tape, record, exhibit or portray them as the as or Winner/Participants and/or publish any Contest Entries content submitted by them, feature them in video shoot/recording if any during the collection of the Prize. The Participant expressly agrees to his /her subsequent participation, if any being recorded and telecast as a part of the programs of Organizer or otherwise and/or for promotion of the programs and/or on a stand-alone basis, as required by Organizer through any mode, mediums and formats, whether existing now, or developed in future ("Recording") and all the all rights (including intellectual property rights) in and to such Recording shall be deemed to have been assigned exclusively, in perpetuity, and throughout the entire world, in favor of Organizer. The Participant hereby agrees that Organizer shall have complete, unfettered and exclusive exploitation rights in and to the Content and have all the rights to exploit, edit, integrate other content with Content, distribute, exhibit, sell, transfer, license, sub-license, monetize and exploit the Content on various platforms and through various format, modes, media including but not limited to satellite, internet, digital, cable, wireless networks (Wireless LANs, WIFI, Broadband) WAP, imode any other modes of wired or wireless distribution or exploitation via radio frequencies etc. whether circuit switched or packet switched. 46. No waiver of any rights by the Organizer will be taken as a waiver of any other rights it may have. For instance, if the Organizer waives its right to object to a particular breach of these terms and conditions by a Participant/Winner, it does not prevent the Organizer

from objecting to any other breaches by that Participant/Winner and/or or any other /Participant/Winner.
