1 General

1.1 These General Terms and Conditions (hereinafter referred to as "GTCs") shall apply to the participation in and the related ticket sales for the above-mentioned event, organised by the above-mentioned Organiser. Any deviating terms and conditions of the participant shall not be valid.

1.2 The organiser reserves the right to make changes and additions to these regulations. Possible changes and additions become valid through publication on this website or on the website [tabletopturniere.de](https://www.tabletopturniere.de) (https://www.tabletopturniere.de/t3_tournament.php?tid=33347).

2 Registration, Application and Conclusion of Contract

2.1 The purchase of tickets for participation in the event is exclusively possible via the merchants:

- Fantasywelt.de
- Games-Island.eu
- Taschengelddieb.de

possible. The dealers handle the sale of tickets completely and independently.

2.1.1 The purchase of tickets is subject to German law and the general terms and conditions of the respective dealers.

2.2 The Organiser makes an offer for the conclusion of a purchase contract with the information provided on the website. The participant accepts his offer for the conclusion of a purchase contract by completing the order process. The effective acceptance of the offer by the participant requires that the participant has filled in all the required fields in the order mask.

2.3 Registration for participation in the event is only possible via the website [tabletopturniere.de](https://www.tabletopturniere.de) (https://www.tabletopturniere.de/t3_tournament.php?tid=33347) and is always necessary. Registration at [bestcoastpairings.com](https://www.bestcoastpairings.com) is also necessary.

3. Prizes

3.1 The price stated on the dealer websites is the final price and is binding on the participant.

3.2 All prices include, if necessary, the due sales tax.

4. Payment

4.1 Payment shall be made by the means indicated on the website in each case. All prices are due immediately upon conclusion of the contract.

5. Withdrawal/cancellation/ticket exchange

5.1 If the participant does not wish to participate in the event, he/she must declare his/her withdrawal from the contract in writing or by e-mail to the retailer from whom the ticket was purchased.

5.2 Cancellation conditions

The return and cancellation of tickets is handled by the retailer. The conditions for this are as follows:

- From 23.09.2023 to 31.03.2024 the refund is 100% of the ticket price.
- From 01.04.2024 to 30.04.2024 the refund is 50% of the ticket price.
- From 01.05.2024 no refund is possible.

5.3 Exchange of tickets

If the registered participant is unable to attend the event, the participant has until 25.05.2024 to indicate a substitute person to attend the event by email (business@wuerfelbar.de). The following information and actions are required for this:

The substitute person must register for the event on [tabletopturniere.de](https://www.tabletopturniere.de) and [Bestcoastpairings](https://www.bestcoastpairings.com). The original participant must provide the organiser with the following information about themselves and the replacement person: First name, last name, [tabletopturniere.de](https://www.tabletopturniere.de)

nickname, Bestcoastpairings player name and email address.

6. Services

6.1 The scope of the contractual service within the scope of the event is specified in the information documents on the website [tabletopturniere.de](https://www.tabletopturniere.de)

(https://www.tabletopturniere.de/t3_tournament.php?tid=33347). In case of contradictions and in any case, the service description in the booking confirmation is decisive.

6.2 If services are not provided in accordance with the contract, the participant is entitled to a remedy. Defects must be reported immediately. Claims for reimbursement of the participation fee due to services obviously not provided in accordance with the contract must be asserted within 14 days of the conclusion of the event.

6.3 Travel, accommodation and meals are not included in the event offer. If a contracting party does not make use of properly offered services in whole or in part, there shall be no entitlement to a refund of the participation fee.

7 Cancellation of the event

7.1 For urgent reasons, the organiser may cancel the event with a reasonable period of notice. This also applies to social and evening programmes.

7.2 If the event is canceled, the Organiser shall refund the full amount paid within 30 days. Any additional costs incurred by the participant will not be reimbursed.

8. Visual material/photographs

8.1 The participants of the event irrevocably and free of charge agree that the organiser, the sponsors of the event and other participants, as well as other persons, are entitled to create, reproduce, broadcast or have broadcast, as well as use in audio-visual media, image and/or sound recordings of their person, which go beyond the reproduction of a current event. This may also be done for commercial purposes.

9 Liability

9.1 The Organiser shall be liable for intent and negligence in the event of a breach of essential contractual obligations. Liability is limited to the amount of the participant's fee, liability for consequential and financial damages is excluded.

9.2 Liability for damages on the part of the Organiser is excluded, unless the damage is due to intentional or grossly negligent conduct on the part of the Organiser or persons commissioned by the Organiser.

9.3 Furthermore, the Organiser and its vicarious agents shall not be liable for disruptions of any kind caused by circumstances beyond their control.

9.4 Liability for damage caused during the journey to and from the venues, as well as for losses and accidents, is excluded to the extent permitted by law.

9.5 The Organiser is not responsible for disruptions caused by industrial action or force majeure.

9.6 The Organiser accepts no responsibility for any items brought by customers. They shall be stored on the premises exclusively at the risk of the customer. The customer shall be obliged to remove any items brought along immediately after the event.

9.7 The customer shall be fully liable for any property damage or personal injury caused directly or indirectly by him. The customer shall release the organiser from all claims for damages not excluded above which arise in connection with the event.

10. Waiver

For damages to participating persons as well as their possessions and property, this event and thus the, natural or legal, organising persons, as well as the venue, assume no liability whatsoever. By participating in this tournament, the participating persons agree not to make any claims against the organisers or the venue.

11. Final provisions

11.1 The law of the Federal Republic of Germany shall apply exclusively, to the exclusion of the UN Convention on Contracts for the International Sale of Goods. The place of jurisdiction is Regensburg.

11.2 Should individual provisions of this contract be invalid or lose their validity due to a circumstance occurring at a later date, the validity of the rest of the contract shall remain unaffected. The ineffective provisions of the contract shall be replaced by a provision which comes as close as possible to what the contracting parties would have intended if they had considered the point in question. The same applies to loopholes in this contract.
