**WALK IN INTERVIEW FOR THE POSITION OF PROJECT ASSOCIATE-I**

A walk-in interview for the position of **Project Associate- I** (One Post) under the **Self-Financing Scheme on “Feed and Fodder Technology”** is scheduled to be held on **17.03.2026 (Tuesday) at 9.30 A.M.** in the Department of Animal Nutrition, Veterinary College and Research Institute, Mohanur Road, Namakkal – 637 002. The post is purely temporary and engagement is initially for **three years** period which can be extended depending on the candidate’s performance and requirement in the project. However, revised wages of Rs.31,000/- will be paid from the date of qualification after joining the post. <b>OR</b> <b>ii)</b> Rs 25,000/-+HRA for others who are do not fall under (i) above.
5	Age limit	Not more than 35 years as on the closing date of application. Age relaxation is allowed up to 5 years for SC / ST / OBC / WOMEN / any other special category of candidates as per the rules in force.
6	Duration of the post	Initially for <b>three years</b> . Further continuance will be based on performance assessment and functional needs of the project.
7	Duties and responsibilities	1.To supervise, monitor and coordinate the operation & maintenance of the Feed and Fodder Technology unit. 2. Procurement, feed evaluation, quality control 3. To maintain stock / stores, accounts / reports etc. 4.Teaching / research / extension / product development / validation activities related to feed and fodder technology.



8	TA & DA	No TA / DA will be paid for attending the interview. The candidates have to make their own arrangements for transport, boarding and lodging etc.
9	Enclosures / Attachments	A hard copy of the application along with attachments has to be brought while attending the walk-in interview. Self-attested copies of all documentary evidence / proof to be enclosed along with the application. <b>Original Certificates</b> are to be produced at the time of interview. Otherwise, the candidature is likely to be rejected. If original certificates are not available, <b>certified copies</b> issued by the custodian of concerned certificates may be produced at the time of interview.
10	Written test	A written test in English will be conducted to shortlist the candidates. The syllabus includes feed and fodder technology, procurement methods, feed mill operation & maintenance, feed evaluation & quality control, value addition of feeds and fodders, inventory and marketing management, accounts and finance management etc. <b>A minimum mark to be secured in the written test for attending the interview is 50 %.</b> The pattern will be multiple choice questions for a duration of 45 minutes with maximum of 30 marks.

**Interested and eligible candidates may bring the filled-in application (with photo) along with enclosures for the walk-in interview. The applications need not be sent in advance.**

**Selection Procedure:** The selection will be based on marks scored in the written test, educations qualifications, experience and performance in the interview. Applicants should submit “No Objection Certificate’ if already employed. The selected candidate should work on full time basis.

**Other terms and conditions**

1. The appointment is made purely on temporary basis and the individual shouldn’t claim any University (TANUVAS) service later. The individual has to work on Saturdays. However, they are eligible for other leave as per the TANUVAS rules and regulations.
2. The decision of the Selection Committee in all matters relating to eligibility, work experience, acceptance or rejection of application will be final and binding on the candidates. No enquiry or correspondence will be entertained from any individual.
3. After announcement of the results, the candidate should join the post immediately within prescribed time limit. No extension of joining time will be allowed. The individual has to make own arrangements with respect to boarding and lodging after joining the post. The individual should have valid driving licence (Two-wheeler) at the time of joining the post. A medical fitness certificate has to be produced at the time of joining the said post.
4. The individual has to give prior intimation of 30 days before leaving the job.

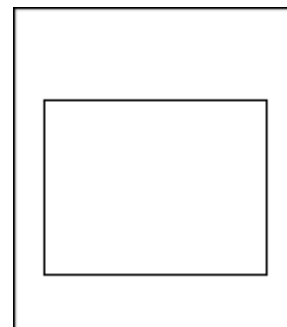
