ENVIRONMENT, HEALTH & SAFETY STATEMENT

As a leading organization committed to sustainable education, the **Ambassador Education Group** of schools (**AEG**) in Chiang Mai - Thailand has the responsibility, so far as it is reasonably practical, to protect the environment and ensure the health, safety and welfare of our employees, teachers, students, visitors, contractors and all the communities in which we operate.

AEG also accepts its responsibility for the environment, health and safety of other people who may be affected by its activities. Consideration is given to ensure suppliers and contractors' provision for environmental, health and safety is compatible with that of **AEG**.

As such, **AEG** will:

- Establish and maintain an Environmental, Health and Safety Management System for all **AEG**'s activities and operations, including setting EHS objectives and targets.
- Undertake risk assessments, implement the identified control measures and ensure that safe systems of work are applied in **AEG**'s activities and operations.
- Comply with the applicable legal requirements and **AEG**'s Operating Standards.
- Provide and maintain equipment, including personal protective equipment, and a working environment that are safe and without risk to health, especially in the event of an emergency.
- Prevent pollution from **AEG**'s activities and operations, reduce consumption of natural resources and incorporate resource efficiency to minimize impacts on the environment.
- Provide as necessary, information, instruction, training and supervision to enable employees and others to perform their work safely, and ensure that the environment is protected.
- Maintain a risk-based emergency preparedness and response program to reduce the impact of emergency events to **AEG**.
- Provide first-aid equipment and trained personnel to provide treatment in the case of accident or ill-health to employees, teachers, students, visitors and contractors to our operations.
- Ensure that all EHS incidents and events are reported, investigated, corrective and preventative actions are implemented, and learning from incidents is shared.
- **AEG** also provides an anonymous channel for reporting. Any EHS grievances or complaints should have relevant detail and information for the issue to be properly investigated or handled.

- Promote a positive EHS culture within the organization, in particular consulting with employees on EHS matters, through the EHS Committees and other forums, to improve their personal responsibility and awareness of EHS.
- Promote the protection and enhancement of the environment through awareness programs and stakeholder engagement.
- Pursue a program of continuous improvement by reviewing our Environmental, Health and Safety Management System and related objectives and targets, policies and practices
- **AEG** is committed to continuous improvement in its environmental, health and safety performance, and ensuring the delivery of the Environmental, Health and Safety Management System is adequately resourced to enable full implementation of this Policy. This commitment includes the provision of sufficient resources, management and employee time, as well as training, and environmental, health and safety advisory support.

It is the responsibility of the Chief Executive Officer to ensure the effective implementation and operation of the arrangements of this Policy. The Environmental, Health and Safety Director is responsible to drive and monitor the implementation of this Policy, and **AEG's** overall environmental, health and safety performance, and provide guidance and technical assistance to all of the operational divisions and support functions, reporting to the Chief Executive Officer and the Board of Directors. All employees are responsible for adopting and complying with this Policy, wherever **AEG** operates.

This Environmental, Health and Safety Policy Statement and the responsibilities and arrangements that support it will be reviewed at least annually or more frequently where there have been changes to the nature of **AEG's** operations.
