Thank you for your leadership with our colleagues in your chapter. In these turbulent times, your support and care for our collegial community is a blessing. Please coordinate with the other leaders in your chapter to ensure that at least one of your leaders attends at least one of the calls. Please also have a conversation with all your co-leaders in advance so that whoever attends is prepared to answer these two questions on behalf of your leadership when we gather:

- How is your chapter making a positive impact for your chapter members and their ministries?
- If you can think of one thing (whether or not you know how it could happen) that would enable your chapter to deepen its positive impact on your chapter members, what would it be?

We hope sharing these responses will be beneficial for you in your roles. It will also be helpful to us as we engage in our ongoing reflection about how we can best advance the mission of the UUMA. We may have additional agenda items and will surely have updates to share as well. More details will be included when we send out the reminder to those who are registered.

Additionally, we would like to ask your assistance in helping reach out to colleagues who have not yet renewed their membership in the UUMA. As part of our membership process we have sent multiple reminders and now ask chapters to reach out. Some chapters pass the names to their good officers, others to their secretary, others divide among their leadership team. However you decide to do this, please do so in the coming weeks so that we can pass the remaining names on to the board for additional outreach before the names are included in the May membership annual report. Finally, I'd like to remind you of one resource I shared on the January Chapter Leader Calls.
