L3 — Deceased Owner/Heirs

Both owners of record (Daniel Harrison Williams and Christine Capper Williams) are confirmed deceased. The property is currently in active foreclosure by Truist Bank (formerly SunTrust). An L3 investigation was required to identify living heirs who can make decisions regarding the property before it goes to auction.

- ⚠ Active Foreclosure: TD for \$25,000 to SunTrust/Truist is in active foreclosure proceedings
- ⚠ Both owners deceased: Title has not been transferred out of deceased owners' names
- ⚠ No probate transfer recorded: No executor's deed or probate transfer found in deed records

Instrument 199904280023944: WD, \$120,000 — Family estate sale of father's property

- Daniel Harrison Williams listed as EXECUTOR of Drew Butler Williams Estate
- Siblings on deed: Margaret Rose Nevels, DruAnna Elizabeth Overbay, Steven Lee Williams
- This independently confirms Daniel's family relationships matching the obituary

No identity ambiguity. Daniel Harrison Williams (b. May 10, 1933, Hancock County, TN; d. July 20, 2025, age 92) is confirmed through tax records, deed records, obituary, and 1999 estate deed where he served as executor.
