Rodzeymer here, I dont know where to go after Peter got the name of the two companyies at st gerard

My idea is to list out all possible pieces. Then see what pieces would definitely not be in the next part. and use clues and leads to determine what is most likely to be in the next part. and try to create a story with the ones we have left.

Nice, that's a good way to do it, looking the dates Peter gone to St Gerard at Thursday, the next ticket is from saturday, so where he was on Friday

So what I think happened regarding the timeline is. Thursday: Pete goes to a meeting. Friday: spended the day talking to the couple and going to St Gerard. And in some pieces

he plans on going home on saturday night but he for some reason has the new info about "Andy" and Philagennia decides to get there instead.

Oh right I forgot. The top part of the document I numbered the pieces and what they could mean. I also explained the thing about "plan on returning home on saturday" too. Oh and I realized just now. He plans to physically "be" at home on Saturday "night". hence the "picking up dinner" and not lunch or breakfast.

Testing various possibilities, but none lead yet, gonna test some thought What do you think would be the next part of the story? or you just brute forcing it rn?

Some bruteforce, I think Pete would call to Hope Mary, but theres must be something in the between, but Im gonna drop for now, return another time, cya!

Cya.

Interesting. I think Mary's Hope is Pete's and Lindsay's hospitals that they lost their daughter at. That's the only logical explanation I can come up with that can fill the jump between finding out about Tempco and Knowing about Mary's Hope.

Yup I think I got the first 2 pieces of part 4 correct. #5 and then #3. There's dialogue changed when I viewed them.

I'm just not sure what can come after Pete calls Mary's hope though.

I came up with a story about Pete getting home after running into a dead end at St. Gerard, but he got a lead of "temp nurse service" and the hospital he and Linds lose their daughter in is "Mary's Hope". Pete then calls Mary's Hope and gets their temp nurses service which also has Tempco same as St. Gerard.

There are 2 possibilities after this event though. 1, the more likely explanation is that Pete somehow got their business card and subsequently website, hacked into it, got their employees list, found Andy's name and location, then brought a ticket to Philagennia. Or 2, the less likely scenario is that Pete gets their employees list through a public source, travels to Philagennia and finds out about their website which has more important information he needs, then he decides to hack it. I'm gonna try to bruteforce them.

I just realized #16 can't be a public source. Since there are employees' addresses on it. So route 1 is probably right. Still no luck on brute forcing though. Simply too much possibility.

Couple of notes about tickets, the ticket to Aosia was a two way ticket, meaning he would have come on on thursday if he took it back home? Not sure

The ticket to Khilagennia is a saturday one way ticket, meaning we currently have no known details for Friday which i feel is frustrating

This is also annoying because I'm so confused how there can be a note that says" Call St. Marys when I get home on Saturday", and the ticket for Saturday morning to theoretically (based off of the info we have now) go to the temp agency place. How would you know thats the temp agency you need to go to if you've never called St. Marys, as you would have done that the night after you were supposed to go to the temp agency! I'm not sure if its an unintentional error date wise or if another clue coming later will shed some light on that note but I've been not including a combination of these clues when I've made my guesses, but i still haven't gotten past stage 3.

This is what I meant by 1 person getting hung up on 1 perspective. Ty for pointing that out, and about what happened on Friday. 1 of part 3 lead the procedure for stillbirth and Pete's note/reaction about it talk about getting home "tommorow". Is that what you're looking for? Because I see that Pete goes to Aosia for 2 day, hence the note lying to Linds about meeting getting postponed.

Found the solution for part 4: #17 #13 #3 #5 #9 (Connect #17 to Gerard temp co(**#14**)) connect #1 to #5, starting from #1 its #6 #15 #16 #8, this unlocks the rest of the board, haven't gotten any further

I need to update the whole thing again damn. Might take a bit.

I was so close huh? #3, #5, #9 are all ranked most likely to be in part 4. Ah well same thing with part 3 so prolly just need a little more luck on my end ig.

Wait? You solved part 5 too?

Yeah that's part 4 and 5 finished, it's just your solution's a little confusing because it's bleeding into 2 evidence of part 3 I think? Those 2 are #17 and #13. I'm gonna need to see if it's activate differently

This might be a good time to start from the top tbh. I'm gonna document every single item and evidence. Going to try for dialogues too if I have the time today since we can now see every single piece of evidence. This is gonna be a little bit of time but I'm free for a bit

And Yeah I just confirmed. Part 5(the group of #1, #6, #15, #16) can't be activate before part 4(group of #3, #5, #9)

I'm documenting the evidences rn, but Snowba11 was right, even with Rain's discovery of both part 4 and 5. Snowba11's concern is still not solved, why did Pete purchase the ticket to Philegennia before he hacked into and knew the location of Andy?

Ok, so I've read through all of the evidences on the second half of the board. I think we can finish the whole game after a day or 2.

Gonna start documenting the rest of the evidences after a break. Finished with all the evidences

In regards to the Philegennia ticket, I'm thinking that maybe that's where we live? The dialogue blurb attached is "after there was no luck with the hospital you came home but you didn't stop there did you" I think that if it was odd there would've been more attention on it, like how there is on the Trenton ticket.

Yeah that could be right. About how Philegennia might be the home of Peter and Lindsay I mean. The reason for Andy also working at that same location could be how Peter and Lindsay meet him in the first place when they have their daughter.

Any leads you have in mind on how the story might progress from part 5, Rain? I'm kinda running into a loop after "Peter breaking in and taking some items".

I'm going to keep working on it tomorrow but with what we've connected so far I'm thinking that your thoughts on Peter breaking in and taking the items are right and then after is the doctors note and the note talking about the painkillers, after that maybe the phone stuff? I'm not sure if that or the items regarding barbs would be next.

That's exactly where I'm stuck as well. I'm trying to kind of make groups like snowba11 talk about. Kinda just threads the items together into coherent parts that I'm sure make sense and then try to piece those bigger parts together.

The big pieces I have rn are "fight-phone-images" which is #25>#30, then #32 and #33 are another piece of "contact with Andy-Paul", and "Barb's Diner" as the last big piece #34>#38

Based on the "doesn't understand yet" and "I don't get it" dialogues from Lindsay though. I'm guessing there's a part/piece in between part 5 and those 3 big pieces. #34 and #35 though. It's really throwing me in a loop. Peter gets the info about Barb's Diner from where? And about Paul too. If Peter knew of Paul from notes he stole in Andy's apartment then how did he know about Barb's Diner?

I got part 6. Finally, I solved something on my own.

I finished it. the whole game.

Part 6 through 9 I already pretty much got an idea of what was going on and didn't finish it yesterday because I wasn't doing it on the game itself and only theorizing lol.
