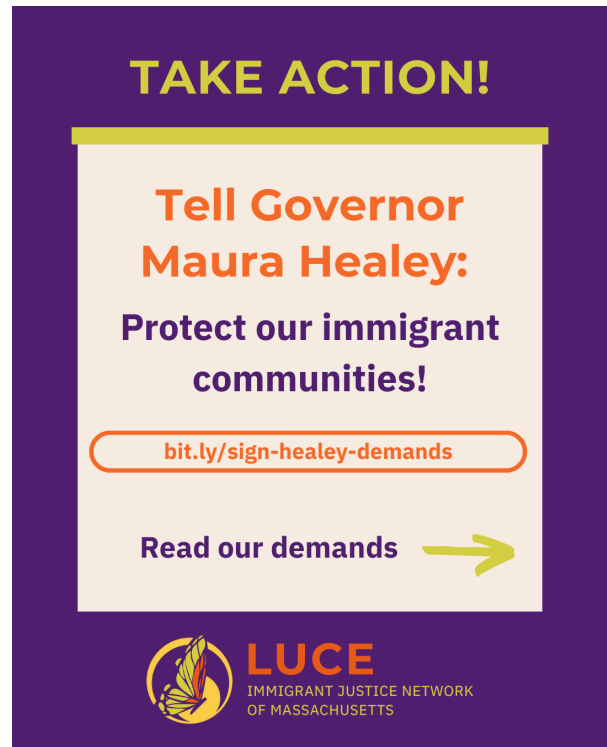

These are abductions. State sanctioned kidnappings. Violations of due process, family integrity, and basic human rights.</p>	

This isn't just lawlessness— it is a direct attack on the values that define the Commonwealth of Massachusetts.

From the displacement and attempted genocides of indigenous peoples, the enslavement of Black people, and the codification of Jim Crow-era laws to the detention of over 200,000 Japanese Americans during World War II and the surveillance of millions of Muslim, Sikh, Arab, and South Asian communities after 9/11.

These tactics are not new and are being repeated across the state. They echo methods used and refined over the 250 years of our nation's history.
