FINANCIAL RESOURCES

The Susquehanna County Career and Technology Center partners with local agencies to assist with funding for Adult Education Tuition assistance, as well as Literacy and Numeracy needs. This service is free to the institution and students.

Annual budget line items account for hiring additional staff. Administration submits proposal regarding the need for additional staff and works diligently with business office staff to procure funding in the annual budget.

Program Department Budgets will include tools, equipment and study materials needed for student success. This department budget is then approved by the Administration so that materials, equipment and study materials can be purchased to ensure student support and success.
