# 2. Amendment to the Compliance Statement

Suggested that the text of B.3 within the Compliance Statement https://www.eduroam.org/downloads/docs/eduroam\_Compliance\_Statement\_v1\_0.pdf is changed as follows:

**B.3**. eduroam SPs IEEE 802.11 wireless networks MUST support WPA2+AES, and MAY SHOULD NOT additionally support WPA/TKIP as a courtesy to users of legacy hardware. Exceptionally, an SP established before January 1, 2012, MAY support only WPA/TKIP but not longer than January 1, 2013.

**B.3**. eduroam SPs IEEE 802.11 wireless networks MUST support WPA2+AES and SHOULD NOT support WPA/TKIP.

and the document be reissued as v1.1. Existing signatories to the compliance statement should be informed of this updated requirement. There will be NO need for them to resign the compliance statement.

[ACTION] Secretary to revise the document and inform all signatories via email of the update

and update this for 1 January 2014. FAQ to be created for the next meeting.
