

Your privacy is very important to us. We want your Internet experience to be as pleasant and rewarding as possible, and to make you feel at ease using the widest range of information, tools and opportunities that the Internet has to offer.

We have created a Privacy Policy to demonstrate our commitment to privacy and security. The Privacy Policy describes how the <https://novostroikinow.ru> page (hereinafter referred to as the "Company" or "our Company") collects information from all end users of its Internet services

(hereinafter referred to as the "Services"),

including people who access some of our services without a registration record

(hereinafter referred to as the "Guests"), as well as customers who have purchased Products

and/or pay a monthly service fee in order to subscribe for the Service (hereinafter referred to as the "Members"). The policy also includes an explanation of what we do with the information we collect and what options Guests and Members have to collect and use such information. We ask you to carefully read the Privacy Policy.

Members may be asked to provide certain personal information when subscribing to our Products or Services, such as name, address, telephone number, billing information. As well as the type of personal computer and the name of the operating system installed on it, which will

be used to access the Services. Members' personal information collected during registration (or at any other time) is primarily used to prepare Products or Services in accordance with your needs, as well as in cases defined by the relevant sections of this policy.

On co-positioned or partner pages: Our Company may share information with partner companies, together with which it implements special offers and promotional activities on co-positioned pages of our site. When requesting personal data on such pages, you will receive a warning about the transfer of information. The partner uses any information you provide in accordance with its own privacy statement, which you can read on the site of the

relevant partner before providing information about yourself.

When transferring control of an enterprise: Our Company reserves the right to transfer your personal data in connection with the complete or partial sale or transfer of our enterprise or its assets. When selling or transferring a business, our Company will provide you with the opportunity to opt out of transferring information about yourself. In some cases, this may mean that the new organization will no longer be able to provide you with the services or products previously provided by our Company.

To Law Enforcement: Our Company may, without your consent, disclose personal information to third parties for any of the following reasons: to avoid violations of law, regulation or court order; participating in

government investigations; assistance in fraud prevention; and strengthening or protecting the rights of the Company or its subsidiaries.

With your consent: In all other cases, before transferring information about you to third parties, our Company undertakes to obtain your explicit consent. For example, our Company may run a joint offer or competition with a third party, in which case we will ask you for permission to share your personal information with the third party.

Internet shopping

When ordering services or products directly from our Company, the personal information you provide is used to process that order. We do not

share this information with third parties except as necessary to fulfill such an order.

Internet advertising

Our company may advertise on the Internet. In such cases, we provide our advertisers with aggregated and non-personally identifiable information about our Guests and Members, collected during registration, as well as through online surveys and promotions.

In addition, in some cases, we use this aggregated and non-personally identifiable information for targeted advertising and joint ventures. For example, an advertiser or joint venture can tell you which audience to reach and provide ads that match. Later, based on the collected and grouped non-personalized information, we place or send advertisements to the target audience. Our company does not

disclose personal information about its Guests and Members to such advertisers or joint ventures. Information on how to opt out of our Company's online advertising is included directly in the advertising materials.

Answers to electronic inquiries

When Guests or Members send e-mail inquiries to our company, the e-mail address from which the request originated is used to respond to them. Our company does not use return addresses for any other purpose or share them with any third parties.

Voluntary customer surveys

We periodically conduct both commercial and private user surveys. We encourage our customers to participate in these surveys as

they provide us with important information with which we can improve our various products and services and improve the way we deliver them. Your personal information and responses will remain strictly confidential even when surveyed by a third party

. Participation in our customer surveys is optional. Information about how to opt out of participating in a survey is included in survey messages.

We may take information collected from individuals who participate in our customer surveys and merge (group) with responses from our other customers to create broader and more aggregated responses to survey questions (such as gender, age, location, hobbies, education, place of work, industry

and other demographic information). The aggregated information is then used to improve the quality of services provided to you and develop new services and products. Such aggregated and non-personally identifiable information may be shared with third parties.

Cookies: Our Company may use cookies to collect information; these are small information files that are stored by your browser on your computer's hard drive at the request of a website. Our Company Cookies do not contain any personal information and are primarily used in the following ways:

- Automatic collection of information
- to keep track of time information. For example, cookies allow us to track which pictures you upload and download;

- to enroll you in special programs. Cookies allow us to remember you when you enter areas of our site that require you to be a Member;
- to remember your country and language preferences;
- to help us understand the size of our audience and traffic distribution;
- to collect and record information about what you have viewed on our site and what you have viewed in our email;
- to manage and manage the information of the site and its presentation, as well as to understand what images can be displayed on your computer; and
- in order to provide you with information in accordance with your interests
