## Esprit de Four, Delegates Report, North District Meeting, October 2, 2021

Meeting was called to order at 9:30 a.m. by Jim Bramham, North District Vice President. 16 Delegates present, 8-guests (guests included Cal-4 Board members; Jack Chapman, Davey Rocha, Steve Egbert, Bonnie Ferguson, Josh Epstein and Russ Chung).

Draft Minutes from April 22 and July 17's North District meetings were (Motion approved) with some corrections.

**Jack Chapman, Cal-4 President**. Jack was at North District meeting helping Jim B. with getting the Zoom system up a running for members who attended the meeting via Zoom. Mentioned Shawn (Promotional Merchandise guy) encouraged us to check out the website; one new item is Cal-4 neck gators.

He recently attended a Rail town 4x4 club meeting. Attended Galt the first "Jeep Super show", event well attended; around 143 Jeeps. **Bonnie Steele, Office Manager.** Mentioned that Mike Magana has volunteered to fill the Historian position for Cal-4 and asking clubs to send him information for their adopt-a-trails. Mentioned John McCready (Corporate Sponsor Coordinator) signed Rhino, as new Corporate Sponsor.
