#### 6. Old Business:

a. 21-22 FAC 6: Appointment of Department Chairs (edited by Murray & Austin)

- i. Continuing the conversation started with the passage of 20-21 FAC 2 amended, detailing Department Chair responsibilities. Section on appointment procedure was removed on the floor of the senate on April 27, 2021. The policy for appointment of chairs still resides with 16-17 FAC 5, the Appointment and Review of Department Chairs Policy and Procedures. The intention is to develop a clean document addressing appointment and review, separate from the policy governing chair's responsibilities (20-21 FAC 2 amended), and remove any remaining language about review and appointment from that document.
