NEW & UNFINISHED BUSINESS

- Alderman Foreman praised the city Planning Board for its plan to target streets for improvement, but questioned the funding source for such a project. Mayor Hogan said he is working with the office of U.S. Sen. Hillary Rodham Clinton, D-N.Y., to have Hornell designated as an "Entitlement Community." Such a designation would be worth up to \$700,000 annually in federal funds, the mayor said, of which a third could be used for blight removal and improving the quality of life in neighborhoods.
- Alderwoman Shepard discussed East Avenue and the possibility of securing funds from the U.S. Army Corps of Engineers to repair a section where the levy wall is coming up to the road. Mayor Hogan said documentation has been submitted to the office of U.S. Sen. Hillary Rodham Clinton to have \$1.5 million earmarked for Hornell in the federal transportation bill for 2005-06. The money, if obtained, would change East Avenue's infrastructure, upgrade water and sewer lines, and improve drainage and lighting.
