Taxpayers who haven't received their W-2 by the end of February should **contact their Employer** to ask for it. Be sure the employer has your correct address.

If employer doesn't respond, call the IRS at 1-800-829-1040 for a substitute W-2. The IRS will send a letter to the employer on taxpayers' behalf. When they call, taxpayers need their:

- o Name, address, Social Security number and phone number;
- Employer's name, address and phone number;
- Employment dates; and
- Estimate of wages and federal income tax withheld in 2017. Use a final pay stub for these amounts.
