Additionally, you may have seen news about recent "swatting" hoaxes—false reports of active shooters—at universities in other states. While these incidents have been disruptive elsewhere, there are currently no specific or credible threats to schools in Michigan.

Please know that Corunna Public Schools takes student safety very seriously. Under the guidance of our Head of Security, Larry LaFramboise, and school resource officer Steve Skerbec, we maintain close communication with law enforcement, the Michigan Intelligence Operations Center, and we have clear procedures in place should an emergency arise. Our staff is trained to respond promptly, and we regularly review our protocols to ensure the safety of your children.

I can assure you that we would work together with law enforcement to prosecute anyone committing a hoax against our district to the fullest extent of the law.

While the start of the school year brings excitement, we also recognize the importance of vigilance. Together—with families, staff, and community partners—we are committed to ensuring that every student feels secure and supported at school.
