## **Course Description & Learning Objectives**

Welcome to English 10! Over the next few months we'll explore diverse voices across global literature, seeking to listen to different perspectives and to identify common ground among us. Additionally, we will practice effective research methods and writing effective arguments. - 5. You will engage with perseverance in a long term writing process, gathering and responding to effective evidence, formulating and organizing an effective thesis, and drafting and revising towards a product.

If you want a higher grade...

from the first draft of a paragraph or essay, you may (1) review my feedback, (2) complete any required remedial assignments, (3) meet with me, (4) make all revisions in a different color ink, and (5) turn it in before/by the rewrite deadline into the rewrite assignment in Canvas.

If you want to retake a quiz

you may (1) complete any required remedial SBA assignments and (2) arrange to retake the quiz within a timely manner.

#### **Incompletes Policy**

English 10 is a required class for graduating from Del Oro and for college admissions. Students who do not earn at least a C require some form of credit recovery, which could involve repeating the class.

## **Absences & Late Work Policy**

Students are responsible for making up any work missed due to absences or tardies. A daily agenda is posted on our class website each day detailing what we did.

Do I accept late work? The short answer is yes. Missing work does not have to stay missing and does not have to permanently affect your final grade. If Aeries says it's missing, you can choose to fix it.

The better answer is: not whenever you feel like it. In order to help students grow stronger in their ability to take care of themselves, I will accept late work, but I will only occasionally enter it into Aeries. Late work will appear to be missing for a while, and your grade will temporarily carry the weight of your choice not to do what it takes to finish your work on time. I provide lots of time and support during class for students to get work done, so if something is missing, that's on you. Yes, there are exceptions for excused absences. Yes, you can fix it and turn it in late. Accountability is a support that helps you grow stronger.

## **Academic Integrity Policy**

**Plagiarism** is submitting another person's work, claiming that it is a demonstration of your own skills and abilities. It is not only dishonest, it defeats the purpose of education—developing the skills and credibility you need as readers, writers and thinkers who can thrive and command respect in the real world.

Students who have been found to have cheated on assessments or to have plagiarized writing assignments have broken my trust and must repeat the assessment, perhaps with a more difficult version, perhaps with new restrictions, perhaps with required remedial work, and perhaps with referral to the administration for additional consequences.

Cheating includes: Submitting someone else's work, claiming that it's your own; Not citing research sources properly; Inventing false research information; Using improper materials during a test or quiz such as cheat sheets, notes, phones, smart watches, headphones/earbuds, etc.; Reading another student's work or talking during during an assessment (like a test or a quiz); AND helping another student do any of the above—even if another teacher catches you

#### **Del Oro High School's Technology Policy**
