## Terms Of Services

By commissioning me you have stated that you have read and agreed to the following terms:

Turn out time can be anywhere from 2 days to 3 months in the case of an emergency or high workload from my schooling or IRL job. This time is simply padding, do not expect a piece to take 3 months without warning you before hand.

- I use only PayPal, Stripe, and CashApp at this moment. Full payment is requested upfront, I will not start your piece until I have received the due payment.
  - If you need to budget your payments into installments please say so and we will discuss how to move forward with this.
- Slots are opened again once ALL previous slots are finished. You may order up to 300\$ worth of pieces in a slot, nothing more than this. I would feel incredibly guilty if it was more and I wasn't able to get it to you in a timely manner.
- When a big milestone comes up in your drawing, you will be asked questions unless it is a complete artistic liberty piece, or you have stated that you give me complete artistic liberty. At this time you can request a WIP screenshot, you may request it if I have stated that I have worked on your piece. I am also a college student and working on other projects besides yours, so I may not get to yours every day. Typically I try to give you a WIP shot at the end of the work time, so you may not need to request one.
- I only give up to 3/4 refunds. Why is this? I put my time into starting your piece and if you don't like it, I'm sorry. I try to update you as much as I can and get as much input into the piece as possible to avoid this. If at some point you no longer want the piece, I will refund 3/4 of your slot only. I may offer to rework the piece depending on your attitude towards me.
  - Refunds will not be given for time issues. If I was not able to finish your piece in the time I have said I will, I will notify you at least a few days prior so you get the heads up. I will continue to work on your piece until it is complete and send you the finished piece.
- Once the sketch is finalized by you, any significant\* re-work done after that stage will
  cost extra

- \*Significant is defined by me, but think of it as changing a large area (10% of the subject or more), more than 3 minutes, or is a complex part of the piece.
- If you are rude to me, you will be blacklisted and given again only a half refund. I am a
  human being, just as you are. This is my job, this is my income. I do not deserve
  disrespect when I am creating something for you at a decent price.
- I have full copyright to all artwork and unless requested from the commissioner, they will
  be shown on my platforms. If you do not want something posted on my platforms, or a
  certain platform, please notify me BEFORE the finished product is given. You may post
  the work only if you give credit for the artwork to me. As long as the horn is blown that I
  made this, I'm chill with whatever you do with it.
- I REFUSE TO DO NFTS (Non-Fungible Token). Reading and agreeing to this T.O.S states that you:
  - o Do not currently own, produce, or plan to do anything with NFTs in the future.
  - Use my art as an NFT.

If you have an issue with the above bullet, I'm sorry. I'm not the artist you want to use, nor do I want your time, money, and waste of effort.
