# The 6<sup>th</sup> Equitable Education Alliance (EEA) Meeting: Exercising Equity to Deliver an Inclusive Classroom

7th February 2023 Zoom Meeting

#### I. <u>Summary of Discussion</u>

- 1. The EEA Secretariat and EEA members identified opportunities for engagements with various equitable education practitioners at different platforms while promoting EEA and equitable education initiatives: Identify collaboration with various stakeholders from national to international levels for a stronger strategy to create equitable education. Increase the public visibility and influence of the EEA to promote the vision and implementation of equity education as an important aspect in achieving SDG4 goals. Communicate future updates and activities of the EEA members through a dedicated LinkedIn group page.
- 2. The EEA Secretariat and EEA members identified opportunities for joint-organize learning and training programs of subject/skill accreditation: Collaborate with implementing organizations to organize various conferences and programs to exchange relevant knowledge of practices, programs and promising cases globally, as well as create equity-based education oriented online/offline training courses to public. Provide visibility to EEA members to jointly create an ecosystem that supports and assists all member organizations to share resources and capacity building.
- 3. The EEA Secretariat discussed and clarified the revised Terms of Reference (ToR) for members' acknowledgement.

# 4. Advocacy and Communication:

- a. Showcase country experiences and organize study tours to explore equitable education practices.
- b. Develop a guide or collective publication, including a blog post of members' knowledge sharings, researches and best practices that include impactful equitable education approaches and distribute to different equitable education practitioners.

## 5. Partnership Building:

- a. Work on collective research and provide joint-training workshops for staff of EEA members.
- b. Develop a regional policy framework on equitable education. 1

- c. Build progress on school visits as benchmarking to evaluate the outcomes of equitable education for peer reviews.
- d. Create a clear funding scheme<sup>2</sup> to identify common areas to promote equitable education.

- a. Connect all the working groups among EEA members<sup>3</sup> on the national level to implement practical action on the provincial level evidence-based with members to showcase statistics for support data publicly.
- b. Create a mapping exercise on what research on equitable education is being done by the EEA members.
