# Goal #1

The goal of our Land Trust funds is to provide exceptional instruction for our students. Teaching quality is one of the strongest influences of student success. We strive to hire and retain highly qualified and effective teachers and paraeducators (instructors) across all grades. This practice opens the general education classroom to many of our special needs students and allows us to personalize student learning for all students in reading, spelling, and math at their precise, instructional levels. This is a powerful aspect of our model, yet it greatly increases our human resource expenses. This has the impact of having downward pressure on our teacher and staff salaries.

American Principles Academy will use 100% of the allotted money in Land Trust funds toward instructor salaries and benefits across grades K-8 in order to support and improve the quality of instruction for all students.

By using the School Land Trust monies toward instructional salaries and benefits, the students at our campus will be well-instructed in core subjects as well as in their targeted achievement level groups. This will result in greater concept mastery and higher assessment outcomes.

# Academic areas pertaining to this goal

English/Language Arts and Mathematics

#### Specific measurement used to determine progress towards the goal

As this will be our first year of operation, we will use this year to obtain baseline student achievement data on the RISE ELA and Math, as well as the Acadience Reading assessments. Because Acadience gives us BOY student data, our goal this year will be to reduce the number of 1<sup>st</sup>-3<sup>rd</sup> grade students in "Intensive" at BOY by 5% by EOY. We will use baseline student data established for the RISE in 2025 in grades 3-8 to create additional School Land Trust Plan targets for ELA and Math in 2026.

## Action plan steps to reach this goal

American Principles Academy will use 100% of the allotted money in Land Trust
Funds toward salaries & benefits for instructors in order to support our model of
having instructor support in every elementary classroom and increasing the
quality of teaching through the retention of highly qualified teachers across all
grades.

The amount for 2024-2025 is estimated to be \$50,252.48.

2. Teachers and paraeducators will use embedded assessment data to determine skills mastery in their achievement-level groups throughout the year, and to reassess accommodations, modifications, and placement in order to maximize learning for each student.
