

Ski Club Participation Agreement

I understand that as a school activity Ski Club is an extension of BCHS, and all school rules and expectations will apply and be enforced with the ski club as they would at school.

I understand that the rules of the ski hill will be respected. If I am skiing or snowboarding recklessly I will be removed from the hill by the ski patrol and/or ski club advisors. Parents will be notified when this behavior occurs.

If an advisor or ski patrol asks me to correct inappropriate behavior, I will discontinue the behavior immediately.

If I have been asked to stay off the ski hill, I will sit in the ski lodge without any further incident. If not, my parents will be called to pick me up.

Helmets are required by the BCHS Ski & Snowboard Club, regardless of ability. I will always wear my helmet when I am on the hill.

I am responsible for any damage to my equipment (rental/own). I am also responsible for locking up my equipment or storing in "Corral" (ski locks can be purchased at ski shops).

Failure to follow any of these guidelines may result in loss of ski club privileges and/or membership.

**Notice of Transportation Responsibility, Acknowledgment, Assumption of the Risk, Waiver and Release
Relating to Transportation**

Due to the present bus driver shortage, the Elmbrook School District has determined that it will be unable to provide transportation for some student activities during the 2025-2026 school year. As a result, the parent will be responsible for providing transportation for their student or otherwise making arrangements for them to be transported to and from extracurricular events in which they are participating.

By signing this agreement, I acknowledge that it is my responsibility to make arrangements for my student to be transported, by myself or another private party, to and from Alpine Valley, W2501 Co Rd. D, Elkhorn, WI 53121 for all WHMS/BCHS/BEHS/PPMS Ski and Snowboard club trips during the 2025-2026 school year. I voluntarily agree to assume the full risk of any injuries, damages, or loss, regardless of severity, that my student may sustain as a result of or connected with receiving transportation services, including but not limited to, injuries, damages, and loss arising out of negligent operation and supervision of the vehicle. I acknowledge that my student is not within the supervision of the District during the time in which they are being transported and that the District has no responsibility for my student during that period of time and release the District from any liability related to the transportation of my student to and from this activity.

I voluntarily agree to assume all risks and accept sole responsibility for any injury to my student or myself, including but not limited to, personal injury, disability, death, illness, damage, loss, liability or expense, of any kind, that I or my student may experience or incur in connection with my student's transportation to or from District-sponsored activities.

I further agree to waive, discharge, release, protect, defend, hold harmless and fully indemnify the Elmbrook School District, as well as the event sponsors, employees, volunteers and their representatives for any liability, claims, causes of action, or demands, including attorney fees, fines, fees, or other costs (e.g. medical costs) arising out of the transportation of my student, that is brought against the School, School District, or the event Sponsors, employees, volunteers and representatives by me, or my family members, whether such claim arises from the alleged negligence of the District, the negligence of its employees, volunteers, representatives, by the negligence of any other Activity participant (known or unknown) or by my own negligence.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, AND UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT. I FURTHER CERTIFY AND REPRESENT THAT I HAVE THE LEGAL AUTHORITY TO WAIVE, EXONERATE, DISCHARGE, RELEASE, AND HOLD HARMLESS THE RELEASED PARTIES ON BEHALF OF MYSELF AND THE BELOW-NAMED STUDENT. I INTEND MY SIGNATURE TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW.

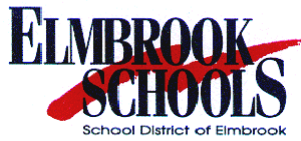
