## A Constituent What Now? (1)

We explain in more depth what this type of meeting in two documents in the folder you'll get linked to further down in this document, but here's the TL;DR: We're hosting this type of meeting, which is based on Swedish organisation and association-starting because that is what I (maloki) have experience with. This is a starting point, and can change based on the decisions of the group. The full explanation can be found in the two documents labeled 1, see next point about Meeting Documents.

## **Meeting Documents**

This will also involve a lot of other documents, all of which will be provided in WIP (Work in Progress) form, and we do not need formal decisions to edit them at this point in time. Instead, we aim to find a common goal to work towards and make sure our documents align with that. We are all here for an already quite shared vision, and hopefully we can properly convey that both in our documents and our practice in this community.

At the meeting, we will make decisions on whether we can accept the documents in their current form, or as a temporary measure. Usually an organization won't actually accept these until the 2nd meeting, which will be the first real annual meeting of the association, in whatever form it takes.

#### **Editing the documents:**

Sometimes the better option is Editing, while at other times it's better to change to Suggesting mode when you want to start a discussion on something. You can also suggest a full paragraph. We advise that you utilize this at your own discretion.

#### Meeting Agenda (2)

As this first meeting should not be too extensive, but rather get us started and choose a committee of people who can represent us in the continued work to make the actual organization, we may not want to add too many additional points.

## About working on the CoC together until the meeting (3)

We know that a Code of Conduct is vital for a healthy working environment, and that getting a CoC right is not always easy. This is why this meeting invitation comes with a lot of documents, a whole folder actually, because we're going to work on this together. There are two documents for the CoC work, labeled 3 and 3.1. The first one, 3, is the CoC for the meeting in particular, while the second one, 3.1, is for the Association.

# About contributing to figuring out what type of organization this association should become (6)

Should we form a co-op? What other governance structures might be appropriate? We want you to suggest possibilities, and to join in researching them!

## **Working groups**

Before the meeting, you can already start thinking about specific working groups to which you would like to contribute. Our basic suggestions for work groups are listed on the agenda. You can volunteer for these, and we welcome you to suggest others. And if you do bring suggestions (like we hope you will!), we can either talk about them at the meeting, or plan follow-up discussions.

## Name suggestions—and Taglines (7)

Since the names "ForkOff" and "ForkOffTogether" are a bit too close to a big cry of "Fuck You" from all parties involved, this isn't the best basis on which to start an organization. So we need to start thinking about new names, and talk about their pros and cons before the meeting.

The same goes for the tagline. I started saying "org first - code later", which in a few iterations turned into Community Over Code. This may stick, it may not. Start talking among yourselves, and bring some suggestions to the meeting, or use document 7 for it.

Thank you for taking your time to reading all the way down here, and thank you for all the support you've showed thus far. The road will continue to be bumpy, but I believe that we can do this together.
