## Reflection:

After viewing Thomas' annotated bibliography, which was also in APA style, I realized that although we used different style guides, the formatting was the same (as it should have been). Thomas and I both struggled with the formatting of our citations in blogger, however, they look fairly similar. However, in Chloe's annotated bibliography, there is no specific citation format for her major! In her bibliography she calls it, "Journal of Neuroscience Style."
