Checklist:

- 1. Complete the **online application** form on the Federal Police website (available <u>here</u>). Remember to print and bring the form.
- 2. Bring your **original passport** and a simple **copy of the following pages: identification page, Brazilian visa, and entry stamp to Brazil**. The Federal Police in São Paulo requires these copies, even if they are not mentioned in the official checklist.
- 3. Ensure you have the **original visa application form** issued by the Brazilian Embassy/Consulate. <u>Issues with your visa or visa application form?</u> If you arrived in Brazil without the original visa application form or if the Brazilian Consulate made a mistake in issuing your visa, your application will not be accepted by the Federal Police. To rectify these issues, please contact the Ministry of Foreign Affairs Office in São Paulo (Escritório de Representação em São Paulo ERESP), responsible for consular assistance. They can <u>correct visa errors</u> and <u>issue a new visa application form</u>. Website: https://www.gov.br/mre/pt-br/eresp.
- 4. Complete the fee payment form (GRU) (available here). Ensure to bring a printed copy of the GRU along with the payment slip.
- 5. If applying for a family reunion visa (VITEM XI), submit the sponsor's identification document.

6.	In case the Federal Police biometric data collection system is unavailable, you may be requested to provide a recent color photo , 3x4 cm in standard size, taken against a white background, on smooth paper, facing forward.
7.	Schedule an appointment with the Federal Police (available here) and bring a printed confirmation on the scheduled day. If applying through USP, bring a printed copy of the confirmation email as proof of your appointment.
