Treasurer Report

No treasurer report was given. No one was available at the time.

Minutes

A review of the minutes from the previous meeting was done. Motion was made by Kendra Stevens to accept minutes and Traci Seconded.

Committee Reports

Membership:

Nothing to report at this time.

Legislative:

Ryan Crockett stated the new session is next year. He mentioned keeping track of HB272 which raises the age to 18 for juveniles. This will affect Juvenile Courts and have an influx of youth to courts. The Senate has proposed a substitution from the March 2022 session.

Scholarship:

Report was given for Carvelle Taylor as he was not at the meeting. Kimberly Scott reported that Carvelle has found someone to donate a TV for a raffle for the scholarship. He will get with John Johnson to possibly have a basketball tournament to raise money.

Nominations/Elections:

By-laws:

Charlatte announced that Kendra Stevens will be the new By-laws chair.

Fundraising:

Eric Thompson reported that there will be information soon for people to order items such as tumblers, mugs, etc. They will attempt to do raffles for gas cards. Website:

Report was given by Charlatte as Stanford was not present. Stanford made a change to the website showing a move of the TBA tab under announcements. Also, it has been updated that Charlatte is the temporary chair for Community Service until permanent chair is found.

Community Service:

Charlatte reported that there is no current chair for community service and if anyone is interested that she can be contacted. Charlatte will chair until permanent chair is appointed. Traci will also assist with needs until chair is appointed.

Education/Training:

Robin Heard reported there is no current updates and that she will continue to send out emails about available zoom trainings or anything on WebEx.

Conference:

Charlatte reported dates are being set up for site visits for the two sites Callaway Gardens and Athens. Athens is supposed to submit all their information by end of day. If this does not happen, then decision will need to be made about going with just Callaway or finding another alternative to Athens. Daniell reported that Callaway Garden dates of May 30- June 2 there are 40 lodge rooms at \$199 plus a \$30 resort fee. There are 10 rooms of 2-bedroom cottages at \$319 plus \$40 resort fee. June 6-9 more lodge rooms will be available. There will be clarification on the resort fee if it is daily or a one-time fee. The committee will continue to work on vendors, speakers, and activities for the conference.
