

## **Terms of Service (TOS)**

Please read these Terms of Service (TOS) carefully before using Anime Vanguard Banners, a Discord bot developed by Humzy. These terms govern your use of the bot and outline your rights and obligations as a user. By using Anime Vanguard Banners, you agree to be bound by these terms. ### **Definitions**

- 1.1. "Anime Vanguard Banners" refers to the Anime Vanguard Banners Discord bot developed by Humzy.
