Background

Application and Confirmation Process

A nomination for Honorary Life Membership shall be sponsored by three members of the Society and shall be accompanied by a supporting citation/application form.

The completed form shall be submitted to the Secretary (details below). Nominations will be considered at the next available Council meeting.

Election of the candidate shall be determined by the full Council and shall be confirmed by a majority of at least two-thirds of those voting at a duly announced Business Meeting.

The Award

Honorary Life Members shall be acknowledged by the Society and pay no subscription to the Society but shall be bound by the Articles and Rules of the Society and shall be entitled to normal voting privileges.
