BEFORE ARRIVING AT MEADOW CREEK

QUESTION: Will there be accessible parking at the festival?

ANSWER: Yes, there is accessible parking available at Meadow Creek. All parking requires a ticket. Please note that all vehicles that park in the accessible parking area must have a government-issued accessible plate or placard upon entering the parking area. If you are in need of accessible parking and do not have a government-issued accessible parking placard or plate for the vehicle that you will arrive in please email: access@meadowcreekco.com.

QUESTION: ARE THERE SHUTTLES TO MEADOW CREEK?

ANSWER: Yes, there are shuttles for purchase, shuttle services will be provided to and from Denver International Airport and Downtown Denver. You can see options to purchase, here: [MCM SHUTTLE](#) Pickups from these locations will be scheduled for Thursday or Friday (depending on your arrival plan), and return shuttles will depart from

Meadow Creek on Monday. These shuttles have accessible options. If you have any questions please email us.

QUESTION: IS THERE AN ACCESSIBLE DROP-OFF AND PICK-UP POINT AT MEADOW CREEK?

ANSWER: Yes, you can drop off at the Box Office.

THINGS TO CONSIDER WHEN COMING TO MEADOW CREEK

Safety: Meadow Creek and all the awesome things happening are for everyone and, for everyone's safety all patrons are required to the same security screenings and safety allowances/ restrictions that are outlined below. MEADOW CREEK ITEMS ALLOWED INTO THE VENUE:

- Empty Reusable water bottles:
 - In the interest of minimizing plastic waste, we highly encourage all fans to bring an empty reusable water bottle or an empty Hydration Pack with you inside the venue each day and take advantage of our free water stations located around the grounds.
 - If you must bring a disposable plastic water bottle with you into the venue grounds, you may enter with a maximum of two (2) empty bottles.
- Empty Hydration Packs
- Single-compartment backpacks (maximum 12" x 12")
- Purses (maximum 12" x 12")
- Ear Plugs
- Fanny packs
- Makeup
- Hand Sanitizer
- Chapstick and lip balm
- Lotion/Sunblock
- Sealed Tampons
- Eye drops
- Wet Wipe
- Cigarette Packs
- Lighters
- E-cig/Tobacco Vapes
- Vape Juice in plastic bottles (Sealed)
- Cameras (anything but pro equipment – GoPros OK)
- Disposable cameras
- Mobile Phones, external batteries and chargers
- Totems (see Totem Rules below)
- Kandi

- LED Lights
- Flow arts like hula hooping, poi, gloving, orbiting
- Costumes are encouraged! Full face masks must be removed when going through security.
- Bubbles (small sealed container)

ADDITIONAL ITEMS THAT ARE ALLOWED IN CAMPING:

Medically necessary prescription medication:

To enter the venue it must be in daily dosage amounts only, in the original container with label and matching picture ID (if requested) will be allowed. If you have any specific questions please email: access@meadowcreekco.com

Diaper Bags:

INTO THE VENUE: Parents attending with children will be allowed to bring in one diaper bag. This bag should be soft-sided and have no locked compartments.

The bag will be subject to a respectful security screening and search upon entering the festival. This will be the same procedure for breast pumps.

Parents that are bringing in formula or breast milk:

INTO THE VENUE: You will be allowed one small, soft-sided cooler no bigger than 12" X 9" X 9", this cooler will be subject to security screening and search as well. Any parent that is entering with these items, please proceed to the Accessible Lane at the gate, look for the wheelchair symbol. Parents that will need water to mix with powdered formula after entry can go to the Access Center. If you have any questions, please email: access@meadowcreekco.com

ITEMS THAT ARE NOT ALLOWED INTO THE VENUE:

- Illegal substances
- Alcohol
- Open containers: empty reusable water bottles & empty hydration packs OKAY
- Glass of any kind
- Weapons
- Knives
- Pepper Spray or Mace
- Tanks of compressed air, helium, nitrous, etc.
- Aerosol products/cans except Sunscreen and Bug Spray
- Fireworks or any kind of explosives
- Open Flames or Charcoal Grill
- Tiki Torches
- Sky Lanterns
- Animals of any kind
- Professional cameras and or GoPro attachments,
- Selfie Sticks
- Tripods
- Laser Pointers
- Drones
- Large speaker systems
- Frozen water bottles

- Excessively large/long metal key chains
- Large purses or bags (Max 12"×12")
- Stickers
- Flyers
- Beach Balls
- Markers, pens, spray paint
- Paint markers
- Strollers/Skateboards/bicycles/one wheels
- Folding chairs and/or camping chairs

ITEMS THAT ARE NOT ALLOWED INTO THE CAMPGROUND

These items will not be allowed through the gate at check-in:

- Illegal substances
- Liquor:
 - Each camper over 21 years old is allowed only 1 case of canned beer, 1 case of canned hard seltzer, or 1 box of wine permitted per person. [See Campground Alcohol Policy for more info.](#)
- Glass of any kind except handheld and dressing mirrors
- Disallowed vending or selling of any products:
 - Field of Vision will have a bootlegger alley called Mirage City where bootleggers can register for a spot to sell products
- Glass vape juice bottles, plastic only
- Glass lighting. Plastic tipped Christmas-style lights OK
- Large sound systems (if neighbors ask you to turn it down please respect their wishes).
- Weapons of any kind
- Knives- this includes cooking and steak knives
- Pepper Spray or Mace
- Generators:
 - RV onboard generators OK, no external generators
- Selfie Sticks
- Tanks of compressed air, helium, nitrous, etc.
- Aerosol products/cans except Sunscreen and Bug Spray
- Bonfires
- Fireworks or any kind of explosives
- Full-sized propane grill, charcoal, butane or fires of any kind - small propane grill ok
- Tiki Torches
- Sky Lanterns
- Animals of any kind
- Laser Pointers
- Drones

- Golf carts, dune buggies, segways, off-road motorcycles, or self-propelled scooters.
 - **Mobility devices for patrons with disabilities are welcome at Meadow Cree.**
- Large metal key chains
- Spray paint
- Paint markers
- Stickers
- Flyers

Water: There will be water refill stations in the festival, bring a water bottle that adheres to Meadow Creek policy and stay hydrated.

Getting Around: There is a ton to see and do at Meadow Creek! Plan on moving around the festival to see your favorite bands and check out all we have planned. There will be accessible pathways marked for patrons with mobility disabilities, so you can plan the route that is best for you. If you use a motorized mobility device, please be sure to bring any equipment that you may need to recharge your device, Meadow Creek's Access Team will not have that on hand.

AFTER YOU ARRIVE

AT THE GATES:

QUESTION: Is there an accessible entrance through security and the main gates?

ANSWER: Yes, there is an accessible entrance or "Access Lane" for patrons with disabilities. This will be located on the farthest right lane at the entrance gates and box office. Look for the universal symbol for accessibility - the wheelchair.

QUESTION: Can I bring my motorized scooter or mobility device at Meadow Creek?

ANSWER: Yes, patrons with mobility disabilities are welcome to bring their own wheelchairs or electric convenience vehicle (ECV) three wheeled scooters for their personal mobility assistance across the festival. Examples of ECVs are: Hoverround, Jazzy and Rascals. These devices must be operated at a safe speed, approximately the same as average walking speed. Manual mobility aides such as crutches, knee scooters and walkers are allowed.

If you have a specific question about the mobility device that you use, please email: access@meadowcreekco.com. with a photo of the device.

Please note that all devices, motorized or manual will still be subject to a respectful security screening as you enter the park. Please enter through the Access Lane, the farthest lane to the right - look for the universal symbol for accessibility - the wheelchair.

QUESTION: What if I need to bring medication into Meadow Creek?

ANSWER: Medically necessary prescription medication, in daily dosage amounts only, in original container with label and matching picture ID (if requested) will be allowed into the venue. Prescriptions in bottles with valid labels and matching ID will be allowed into camping. If you have any specific questions please email: access@meadowcreekco.com.

QUESTION: What if I need to bring medication that has to be refrigerated?

ANSWER: Medication that needs to be refrigerated can be stored at the main medical tent. The Access Center will have small amounts of ice on-hand, if you wish to keep the medication with you. Please note: Meadow Creek's Access Team will *not* store medication at The Access Center. The same requirements for packaging and amount apply to these medications as well. QUESTION: Where do I go to find out about accessibility services at the event?

ANSWER: The Access Center for patrons with disabilities will be located just before the bridge on the way into the venue. Stop by or email us: access@meadowcreekco.com.

QUESTION: What if I need assistance with accessibility when I am already at the event?

ANSWER: If you are enjoying the festival and find yourself in need of assistance with accessibility, please go to any security staff and ask them to radio the Access Team.

QUESTION: Will there be an accessible golf cart shuttle service at the event?

ANSWER: For the safety of all our patrons, there are no vehicles allowed within the park, with the exception of emergency vehicles. There will be an accessible shuttle by appointment only to outer areas of the venue. Please stop by the Access Center for more details.

QUESTION: If I use a mobility device, how will I get around the festival?

ANSWER: Meadow Creek's Access Team has created and marked accessible pathways to allow ease of travel for our patrons with disabilities. Please stop by The Access Center for more information when you arrive.

ENJOYING THE SHOW

QUESTION: Is there an accessible viewing area for people that use mobility devices so we can see the musical performances?

ANSWER: Yes, we want everyone to experience the beauty of Meadow Creek and all the vibes our shows have to offer. There will be a raised accessible viewing platform for patrons with mobility disabilities. There will also be a reserved ground-level viewing area at this platform as well.

There will be a limited amount of chairs available at the platforms, for use *only on the platforms*. They cannot be removed from the platform for the safety of everyone at the event. If you have questions, please email: access@meadowcreekco.com.

QUESTION: Can my family sit with me on the Accessible Viewing Platform or other accessible areas?

ANSWER: Patrons seeking to use ground-level reserved accessible viewing areas or the Accessible Viewing Platform are welcome to have companions with them. We ask our patrons to be mindful of each other when having their companion seated on the Accessible Viewing Platform with them, as space is limited. That being said, no families with minor children will ever be asked to be separated. Accessible areas will also have seating for companions and companions can be swapped out. Additionally, there will be a capacity posted for this area and the platform. For your safety and the safety of all of our fans, when the capacity is reached no other patrons will be allowed until there is space.

QUESTION: How do I gain access to the viewing platforms and the reserved accessible viewing areas?

ANSWER: You will need a wristband to be allowed on the platforms or in the ground-level reserved accessible viewing area for patrons with disabilities. You can get this wristband (free of charge) at The Access Center, after you have entered the festival. This wristband is **not** your ticket to the festival. Every patron must have a ticket to gain entry to the festival.

QUESTION: Are there accessible restrooms at the festival?

ANSWER: Yes, there will be wheelchair accessible portable toilets in different areas around the festival. You will find that some of these accessible restrooms will have locks on them. Meadow Creek's Access Team recognizes the need to ensure clean restrooms for our patrons with disabilities and will lock some of the units. Please go to the Access Center upon entering the festival for more information and lock codes.

QUESTION: Can I bring my service animal with me to Meadow Creek?

ANSWER: Yes, you and your service animal are welcome at Meadow Creek. Meadow Creek and ALL IN does not support pets being misrepresented by their owners as trained service animals. Pets must stay at home, no exceptions. This is for the safety of all our fans and trained service animals. A rocking music festival is frightening and stressful for an untrained animal.

Emotional Support Animals or Therapy Animals are not considered Service Animals as defined by the Americans with Disabilities Act and therefore are not allowed into our venue.

A Service Animal is one that has been trained to perform one (or more) specific task(s) for the person with a disability that it serves.

What to expect at the gates: When passing through the gates you will receive a short & respectful screening by a member of the Access Team. A band will then be placed on the collar or harness of your Service Animal. This band is purely a visual alert to all our staff that you have already been screened and ensure that you are not stopped and asked multiple times in the different areas of the event. This tag is only for your ease of movement throughout the festival and is not a credential to get you into the festival. You must have a ticket/wristband to enter Meadow Creek.

Please Note: You will not be asked for any documentation for your service animal however, all canine service animals (including those from out of state) must have proof of current and valid rabies vaccination on them or with their handlers at all times. You may be asked for this upon entry. This is the only documentation that you will ever be asked for by ALL IN's Access Team. This is for the safety of all of our valued fans and service animals working at our event.

This is in accordance with Colorado state law.

During the event:

- Your Service Animal must always remain with you at all times & it must be your service animal.
- Your Service Animal must be under your control at all times and have a collar or harness and lead.
- If (for some reason) your Service Animal displays unsafe behavior of any kind, we reserve the right to ask you to remove the animal from the festival.
- There will be Service Animal Relief Areas around the event. Please stop by the Access Center for locations. Handlers are responsible for cleaning up after their Service Animal.
- We reserve the right to facilitate removal and/or refuse access to any animal from the campgrounds or venue if that animal is deemed to be a health or safety threat to festival fans, staff, or other service animals, or in violation of our policies.

OTHER QUESTIONS ABOUT MEADOW CREEK

QUESTION: Will there be ASL Interpreters provided for the Field of Vision?

ANSWER: Yes, there will be ASL Interpreters for Field of Vision. If you have any questions, please email: access@meadowcreekco.com.

QUESTION: Will there be ALDs (Assistive Listening Devices) available at the festival?

ANSWER: ALDs are available by request. Requests must be received by May 15th, 2025 to ensure availability. After purchasing your ticket, please email: access@meadowcreekco.com to make an official request.

QUESTION: Will there be a place to charge my mobility device at the Meadow Creek?

ANSWER: Yes, there will be charging for mobility and medical devices *only* (no phones) at The Access Center. Please note: Meadow Creek's Access Team and Staff are not responsible for securing your devices.

QUESTION: I will need a Braille copy of the schedule, how do I get that?

ANSWER: Come to the Access Center, there will be inclusive schedules available.

QUESTION: What if I am a person on the spectrum and need a place to decompress and reset during the event?

ANSWER: There will be a "Renew You" space at The Access Center. This is a space intended for neurodiverse patrons that can benefit from a smaller, quieter space to reset and then rejoin the festival. This is not a lounge.

QUESTION: What if I am a nursing mother, will there be a place with privacy for me to nurse or pump?

ANSWER: Yes. There will be a "Parent Pod" at The Access Center. This will provide privacy and power for you. There will also be bottled water available if you need to mix formula.

QUESTION: What if I am a parent and I would prefer a more private area to change my Meadow Creek Kiddo?

ANSWER: There will be a "Parent Pod" at The Access Center. This will be a space that you will find a little more privacy to change your kiddo. This is not a lounge and is intended only for parents with children.

QUESTION: What if I need to bring in a chair?

ANSWER: For the safety of all our patrons, chairs are not allowed into the venue. There will be chairs available for use at the accessible viewing areas. These chairs are not allowed outside of the viewing area. If you have a specific accommodation request regarding chairs, please email: access@meadowcreekco.com.

QUESTION: What if I have a medical condition that I need to bring in food for?

ANSWER: Outside food and drink are not allowed into the venue. If you have a specific accommodation request regarding food, please email: access@meadowcreekco.com.

QUESTION: I have food allergies, how can I find out about food options?

ANSWER: You can come to the Access Center and get information about food vendors and ingredients. If you have specific questions, please email: access@meadowcreekco.com.
