#### **Government Intervention and the Arts**

Juli Consigli is a producer specialized in the entertainment industry and cultural management. She studied Scenery and Stagecraft at the Colon Theatre and Graphic Design at the Buenos Aires University of Argentina. As executive producer, she has built and led dynamic production teams, worked with most important brands, artists, events and festivals, nationally and internationally, and due to her job, experienced to work on major entertainment venues of Argentina and abroad. Among her jobs leading teams are, the General Production and Technical Coordination of the Kirchner Cultural Centre in Buenos Aires, Executive Production of the MUTEK Argentina Festival, Production Manager of José Carreras, Technical Coordination of Urban Park Youth Olympic Games, Production and Direction of MKT Sony. She has produced classical music events, live shows and art installations with Brian Eno, Phil Manzanera, Daniel Barenboim, Martha Argerich, Gustavo Dudamel, Ute Lemper, Juan Paul Gaultier, Egberto Gismonti, Plácido Domingo among others. In 2017 she created the FIME (Festival Internacional de Música Electroacústica) and she runs Virtuoso Records a classical music record label who aims to promote latin american composers and musicians.

Cecilia Kuska was born in Argentina and is currently based between London and Buenos Aires. She is a Cultural Manager with a focus on the crossroads of disciplines and cultural diversity. She has worked for cultural projects around the globe including Argentina, Chile, Cuba, Belgium, Brazil, Germany, Italy, Russia, United States & United Kingdom. Her former roles include General Producer & Artistic Assistant of the Buenos Aires International Festival (FIBA), head of the production at FAENA ART and FAENA Festival and Programming Director of the Buenos Aires Cultural Management Ministry and also worked as a dramaturg for the programme Power talks III at the Het Theater Festival Gent. Last year, she joined CASA London's Festival of Latin American Arts team as a festival producer and she is serving as co-curator of PROXIMAMENTE Festival at KVS Brussels City Theater and as guest Curator for Santiago a Mil Festival 2021. At the same time, she is the international manager of different artists such as Fernando Rubio, Grupo Krapp and Josefina Gorostiza, among others.

Claudia Billourou is a stage director, set designer and costume designer with works in Germany (Schauspielhaus Bochum, Theater Dortmund, Theater Freiburg, Staatstheater Kassel, Gorki Theater Berlin, Theater Leipzig, Theater Luebeck, Theater Tuebingen, National Theater Mannheim, Theater am Goethe Platz /Bremen, Grillo theater/Essen and Schauspielhaus Hamburg, among others), Austria (Salz Depot, Vienna), Switzerland (Theater Basel and Schauspielhaus Zuerich), among others; Teatro Julio Mario Santo Domingo (Bogotá, Colombia) and in Argentina (Teatro del Bosque, Teatro Nacional Cervantes, Teatro de la Comedia of the Buenos Aires Province and Teatro Argentino of La Plata/Ginastera, TACEC and Sala Alejandro Urdapilleta/TAE). She worked also in scenic/installation projects in Dresden, Karlsruhe (Germany) Dehli (India), Havana (Cuba) and Fundación Proa (Argentina) among others; and holds a Chair specialized in Action Spaces at the Hfg/Art Academy Offenbach and the Theater Academy des Landes Hessen (Germany), among others. She was the creator, together with artist Leandro Hilario Torres, and is the director of the TAE (School of Art and Trades for the Contemporary Show of the Argentine Theater of La Plata).

Gerardo Salinas is a Belgian artist and curator of Latin American origin. He is an art fundamentalist regarding new urban contexts, characterized by ethnic diversity, cultural hybridization and new narratives. In his works, he investigates the artistic possibilities of cities through different creations, networks and projects. Some examples are the WIPCOOP platform, the Mestizo Arts Festival, the MAPping work or the Mural exhibition. He has created the concept of Urban Dramaturgy that he develops from the Koninklijke Vlaamse Schouwburg (KVS) in Brussels. He works on the KVS artistic direction team and at the same time as a playwright in plays such as Dear Winnie, L'Homme de la Mancha, Drarrie. In 2019, together with partners from Argentina, Chile, Brazil and Uruguay, they launched the PROXIMAMENTE platform for the international dissemination of performing arts from a Latin American perspective.
