SECTION I: INTELLIGENCE BRIEFING

OPERATION BRIEF:

Stormwind Intelligence indicates that over the course of January through March of 41 L.C., fighters and dissidents loyal to the Kurzen Rebellion have been freely able to muster in Kurzen's Compound in Stranglethorn Vale due to Stormwind's occupation with the Scourge Invasions and the absence of His Majesty, King Anduin Wrynn. The Kurzen Rebellion has raised a significant force that poses a threat to the Kingdom of Stormwind.

While the Kurzen Rebellion alone is cause for concern, Stormwind Intelligence has also reported that within the past year, there has been great political upheaval in Zul'Gurub over the Zandalari Empire joining the New Horde. A militant faction of Gurubashi trolls known as the Blood-Singers has seized power in Zul'Gurub and have been developing a new Blood Plague similar to the Corrupted Blood Incident which infected thousands in 25 L.C.

Stormwind Intelligence has observed members of not only the Blood-Singers, but also members of the Kurzen Rebellion gathering reagents for and transporting samples of the Blood Plague throughout Stranglethorn Vale. It is our belief that the Blood-Singers have entered an alliance with the Kurzen Rebellion and intend to wield the newly created Blood Plague against not only the Kingdom of Stormwind, but the Alliance, Horde, and any other faction that would stand against them. Infections have already been reported at the New Horde port of Grom'gol and at frontier outposts held by the Kingdom of Stormwind.

With the major powers of Azeroth already weary following the Blood War and the Scourge Invasions, we cannot allow the Blood-Singers to spread a second Blood Plague. The Kingdom of Stormwind calls upon its allies to march on Kurzen's Compound and Zul'Gurub to thwart these great threats to the Alliance.





KEY TARGETS:

Stormwind Intelligence has gathered intelligence on the leaders of the Kurzen Rebellion and the Blood-Singers Cult:

KURZEN'S REBELLION is a collective of human dissidents and rebels primarily composed of deserters of the Stormwind Army. Once led by Colonel Conrad Kurzen, the faction has persisted and mustered a new generation of forces.

CAPTAIN JON MONTAG is a former Ranger of the 6th Stranglethorn Brigade. Then a Sergeant, he is one of Colonel Kurzen's early converts. He is an avid hunter of beast and man alike. He is rumored to possess druidic powers, though this is unconfirmed by operatives on the ground. He adorns himself in sparse plate armor, most notably a helmet shaped in the likeness of a tiger's head, painted red with what is believed to be blood.

CAPTAIN TEMPERANCE CASWELL is a former Battle Mage of the 6th Stranglethorn Brigade. Formerly a Corporal, she is another of Colonel Kurzen's early converts. Her primary areas of study prior to her defection to Kurzen were Divination and Illusion. It is believed that it is through these abilities that she ascended through the ranks and has since maintained this position. Her exact appearance behind her illusions is unknown, but she is the only confirmed woman in the rebel movement's inner circle, and should be identifiable as such.

CAPTAIN GEORG JAEGER is formerly a squire of the Stormwind chapter of the Silver Hand, attached to the 5th Duskwood Brigade. As part of a training rite, he and his mentor attempted to curtail the Kurzen rebels; instead, Jaeger joined them, betraying and killing his mentor. Jaeger is the newest of the currently active Captains. The means of his ascent through the ranks is unknown. He is known to still be able to call upon the Light in battle. He is identifiable by his Silver Hand-issue arms and armor.





The **BLOOD-SINGER CULT** is a relatively unknown and newly formed organization composed of Gurubashi Troll dissidents who rebelled against the Zandalari Empire after it joined the New Horde.

ZUL'SHERA is an accomplished witch doctor and practitioner of experimental voodoo techniques. She is one of the founders of the Blood-Singer cult, which formed after the Zandalari reclaimed control of Zul'Gurub. She is married to Ha'kizi, another prominent Blood-Singer. She does not appear to have been a particularly prominent figure prior to the formation of the cult, but the Blood-Singers have elevated her as "Queen of the Gurubashi". She is rarely seen outside the Temple of Hakkar.

HA'KIZI is a veteran warrior of the Gurubashi Empire, trained by the Bloodbutcher Zir'zo. He appears to be respected by his peers and acts as the mouthpiece of the Blood-Singer cult. He is identifiable by his raptor-skull mask. He is often seen around the city, orchestrating its day-to-day operations under Blood-Singer control. He is known to be charismatic and imposing.

JI'KOZA is a notable voodoo priest, hexxer, necrolyte, and Blood-Singer. He has been observed traveling to various locations throughout the Vale, including the Kurzen Compound and Grom'gol. He is identifiable by his panther-fur cloaks.

ONE-TUSK's real name is unknown. He appears to be a headhunter loyal to the Blood-Singer cult, and acts as a bodyguard and scout commander. He is identifiable by his notably broken tusk.

ZIR'ZO is a venerable Gurubashi war leader known as the Bloodbutcher. He trained generations of Gurubashi warriors, including Ha'kizi, and appears to be one of the commanders of Zul'Gurub's garrison. He notably has not been seen with a Blood-Singer amulet. It is unclear his exact affiliation with the Blood-Singer cult.





SECTION II: MISSION OBJECTIVES

PRIMARY MISSION OBJECTIVES:

The primary mission objective is to secure the Alliance's holdings in Stranglethorn Vale and ultimately to destroy the warfighting capabilities of the Kurzen Rebellion and those loyal to the Blood-Singers Cult, ensuring that the Blood Plague propagated by these factions is cleansed and eradicated so that it does not spread elsewhere in Azeroth. The primary targets of this campaign are Kurzen's Compound, Zul'Gurub, and personnel and officers of the Kurzen Rebellion and Blood-Singers Cult. The Blood Plague is to be cleansed or rendered inert by those trained to do so.

This campaign will begin on April 4th, 41 L.C. with ground forces advancing into Stranglethorn through the Duskwood pass and naval forces traversing the Western coastline of Stormwind. Ground forces shall advance into the jungle, capture Kurzen's Compound, and lay siege to Zul'Gurub. The operation shall persist until either these objectives are secured or the operation is deemed a failure.

SECONDARY MISSION OBJECTIVES:

The secondary mission objectives shall be to build relations with Booty Bay in order to secure favorable trade; to seize oil refineries from the Venture Co. Cartel for Alliance usage; to engage and subdue any regional threats in order to ensure the security of Alliance personnel in Stranglethorn; and to conduct cartographical and archaeological surveys of Stranglethorn for Alliance record.





SECTION III: GENERAL ORDERS

GENERAL ORDERS:

- 1.) All encountered personnel affiliated or allied with the Kurzen Rebellion, Blood-Singers Cult, or Undead Scourge are to be engaged in combat as enemies at war with the Alliance.
- 2.) Conflict is not to be instigated with the New Horde unless under direct order by the ACTING FORCE COMMANDER.
- 3.) Intelligence relevant to Operation: Greenwall is not to be shared with operational allied neutral or New Horde personnel unless permission is given directly by the ACTING FORCE COMMANDER or the ACTING EXECUTIVE OFFICER.
- 4.) In the event that defeat is imminent and that Alliance war machines, naval vessels, or artillery pieces may be captured by enemy personnel, such pieces of equipment should be destroyed in order to prevent their use or study by the enemy.
- 5.) Personnel affiliated or allied with the Kurzen Rebellion or Blood-Singers Cult may be taken as Prisoners of War. Prisoners of War must be given food and water as supplies permit, and must be held in accordance with the Prisoners of War Act.
- 6.) Communication with personnel affiliated or allied with the Kurzen Rebellion or Blood-Singers Cult shall be restricted to the ACTING FORCE COMMANDER, ACTING EXECUTIVE OFFICER, ACTING RECON COMMANDER, authorized agents of SI:7, and individual unit commanders for the purposes of negotiating the release of Alliance prisoners of war, receiving terms of surrender, or interrogation of held prisoners of war. Unauthorized personal communication with enemy personnel shall be considered fraternization with the enemy and be subject to court martial.





- 7.) Only the Chief Medical Officer may keep and distribute samples of the Blood Plague for study. The Blood Plague is to be eradicated through magical or alchemical cleansing wherever encountered. Those found to keep samples of the Blood Plague without authorization or willingly propagate its spread will be subject to court martial.
- 8.) Any encountered artifacts held by enemy personnel infused with voodoo or blood magic are to be destroyed.





SECTION IV: UNIT OVERVIEW

UNIT OVERVIEW:

The Stranglethorn Campaign Task Force is a temporary formation for the conduct of Operation: Greenwall. The formation will be dissolved following the operation.

GRAND MARSHAL MAXEN MONTCLAIR will stand as **ACTING FORCE COMMANDER** and shall be invested with full authority over all Alliance personnel part of this task force for the duration of this campaign, and may appoint field commanders for objectives local to Stranglethorn.

The **TASK FORCE OFFICERS** of the Stranglethorn Campaign Task Force are as follows, by order of authority:

FIELD MARSHAL VINCENT RAVENWING will stand as an **ACTING EXECUTIVE OFFICER** and shall be invested with authority over all Alliance personnel part of this task force for the duration of this campaign, and may appoint field commanders for objectives local to Stranglethorn.

FIELD MARSHAL BROMAS EBONRAM will stand as **ACTING GUNNERY COMMANDER** and shall be invested with full authority over Alliance artillery and war machines for the duration of this campaign.

MARSHAL ZARIA BLACKMOORE will stand as an **ACTING RECON COMMANDER** and shall be invested with full authority over Alliance infiltration and reconnaissance efforts for the duration of this campaign.

CAPTAIN THAUGRIM ANVILRAGE will stand as **ACTING LOGISTICS OFFICER** and shall be invested with full authority over Alliance supplies and equipment for the duration of this campaign.





ADMIRAL NATHUL FURLBROW will stand as **ACTING NAVAL COMMANDER** and shall be invested with full authority over Alliance naval assets for the duration of this campaign.

LORD WARDOM GREYWELL will stand as **ACTING BATTLEMAGE COMMANDER** and shall be invested with full authority over Alliance mages and magical assets for the duration of this campaign.

LIEUTENANT TILLIEA FURLBROW will stand as **CHIEF SECURITY OFFICER** and shall be invested with full authority over all camp security and security personnel over the duration of this campaign.

DOCTOR C'THONIA MOONVEIL will stand as **CHIEF MEDICAL OFFICER** and shall be invested with full authority over all medical personnel and field hospitals established over the duration of this campaign.

DOCTOR GISELLE BECKER will stand as **DEPUTY CHIEF MEDICAL OFFICER** and shall be invested with authority over all medical personnel and field hospitals established over the duration of this campaign beneath the Chief Medical Officer.

IRONGUARD KHUDAAL SILVERBELT will stand as **DEPUTY GUNNERY OFFICER** and shall be invested with full authority over Alliance artillery and war machines for the duration of this campaign beneath the Acting Gunnery Commander.

IRONGUARD BURAINN TRUEFORGE will stand as **DEPUTY LOGISTICS OFFICER** and shall be invested with full authority over Alliance supplies and equipment for the duration of this campaign beneath the Acting Logistics Officer.

COMMANDER ALIA BELIGARDE will stand as an **ACTING FIELD COMMANDER** and shall be invested with authority over Alliance personnel part of this task force for the duration of this campaign.

SIR JULIEN EMBERFALL will stand as an **ACTING FIELD COMMANDER** and shall be invested with authority over Alliance personnel part of this task force for the duration of this campaign.





LIEUTENANT THAELENA RAINSTRIDER will stand as an **ACTING FIELD COMMANDER** and shall be invested with authority over Alliance personnel part of this task force for the duration of this campaign.

Chain of command will originate from the **ACTING FORCE COMMANDER**, followed by the **TASK FORCE OFFICERS**. Following this, individual unit commanders contributing forces to the Pandaria Invasion Task Force shall have command over their respective personnel.
