Payment structure:

- ~~1st Payment (25%) Due at Signing (Today): February 1, 2025 → \$1,475~~
- ~~2nd Payment (25%) One Year Before the Event: October 24, 2025 → \$1,475~~
- ~~3rd Payment (25%) Six Months Before the Event: April 24, 2026 → \$1,475~~
- 4th Payment (25%) – Two Weeks Before the Event: September 20, 2026 → \$1,475

**Catering + Venue: Starline Factory (\$27,678)**

- Final payment \$26,678 due 10/9 (\$1,000 deposit paid 11/18/24)
- Ask about easels - does the venue have any we can rent?
- Final details due 10/2/26
  - Ceremony is at 4PM
- Green room, 2<sup>nd</sup> and 3<sup>rd</sup> floors, and lower levels are strictly prohibited (all vendors, including photos in these areas)
- \$250 security check required (paid)
- Event insurance is required (they must have their own)
- 12.5% staffing fee included (this is gratuity) + 12.5% setup and cleanup fee added to package (rooms are available for setup with prior approval)
- We can begin bridal suite access earlier than 10am (with no extra charge) - grooms have a room too but space closes at midnight
- Will include an arm chair for the Jewish song
- Dinner Package
  - Passed appetizers: spinach & artichoke, caprese skewers, chicken quesadillas (\$200 upgrade)
  - Salad: caesar salad with caesar dressing & ranch served on the side
  - Entree: mediterranean chicken + plated NY strip
  - Late Night: Pizza Bar (\$700)
- Bar Package (can go up to 6 hours at \$100 per bartender fee)
  - No shots or on the rocks drinks (what about people who do not drink)
  - 3-hour bar package included now

- House Gin, Tequila, Rum, Whiskey, Bourbon, Scotch, Brandy, Amaretto + Bud Light/Coors Light/Miller Light + Wine Pinot Grigio, Moscato, Cabernet Sauvignon, Merlot
  - We can set a limit on an overall spend then it moves to an individual bar tab
  - Wedding Party only to have champagne
- Flower petals are allowed but we need to be mindful of them sticking to the floor and shoes. They are very hard to clean up once people have walked on them. She really encourages fake petals instead
- **Cake cutting fee charged \$150 fee**
  - Starline has decorative dessert trays we can use even if we bring in our own dessert
  - Can take-home left-over desserts
  - Chargers may be included (more to come as we get closer)
  - Food tasting 1 year before
  - Linen options are included (4 colors: sandlewood, black, ivory, black + 15 napkin colors)
  - Late night snack can be from an outside vendor (pizza, chick -fil-a, etc). Staff will keep warm (budget permitting). No fees associated with this
  - Tableside wine is available for \$3 per person and wine by the bottle is \$18
  - Two signature drinks are included in the package
- No smoking in the building, smoking is permitted only in the designated areas outside
- No confetti, cold parks, or fog (confetti that is tied to the container, not true confetti)
- Candles and open flames are **not** allowed, only battery operated
  - Candle package will be available through the venue

  - Colors: dark green, creams, deep maroon, blue, orange, pops of yellow
  - Florals: garden roses, thistle, ranunculus, dahlias, delphiniums, daises, grasses & fun textures w/greenery
  - NO: babies breath
  - All vases and candles are rentals (LED pillar and votive)

- Payment can be made by venmo @emilytheharpist, cash or check. Fee is due in full on date of wedding
- Client to pay for any parking expenses
- Overtime and late start fee of \$150 per hour or a late fee of \$150 per 30 minute grace period

### **Transportation: DTC Bus (\$892.50)**

- Drivers phone number as well as Tammie's will be relayed for day-of communication. They will let us know when the driver is heading that way
- There is heat on the bus but AC is an extra hourly cost at \$100
- The 6 hours can be split however we like

- Company allows a maximum of 4x one hour in-person consults to be scheduled within normal business hours
