- Nate: What does emerging disease modelling look like going forward?
- Shokoofeh: Data needs to be gathered from small jurisdictions. What are the contact patterns? Is this information or other data being gathered? Can this data/information be shared? How do we keep the momentum from COVID continuing?
- Amy: report on small jurisdictions group activities to extrernal group, keep this group indefinitely
- Rania: How can we help, empower, etc smaller jurisdictions? How can we provide them with a voice?
- Julien: Small Jurisdictions Working Group should be more official and endorsed by PHAC to get responses we need to do research. Perhaps PHAC-EMNID-SJ?
- Shokoofeh: Get involvement from the communities, share the paper/publication with others and invite participation/collaboration.
- Nate: small jurisdiction modelling have been provided with unique opportunities (nimbleness, networks, bridging across fields)
- Steve G: perhaps we need a Terms of Reference for our group (get EMNID group ToR?) – list what we are hoping to gain from this group. Start a draft and hopefully finalize details at the CAIMS meetings
- Amy: we need more community engagement and direction on how to do this.
 First Nations communities are over taxed. We need to move at a slower pace and forge relationships with communities for growth not burden.
- Steve G: there are 100,000 people under DND to model for. We need to identify the communities that would be involved with small jurisdictions, get the communities involved often and throughout projects, we likely already have a pretty good idea of which communities to reach out to, and this could better put us in touch with resources.
- Rania: What are our objectives and those of the communities? Involve communities from the beginning. We could all piggy back on already established relationships. We should reach out more and often.
