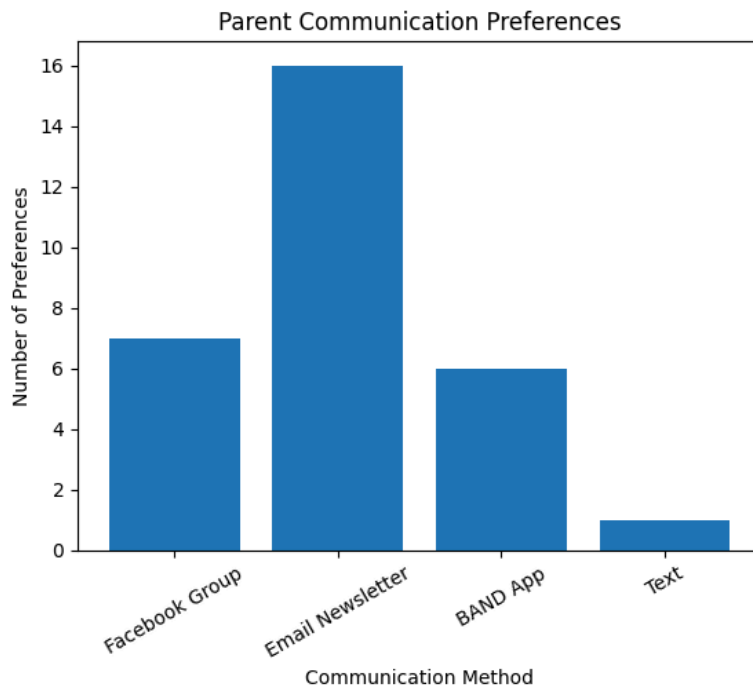

## NEW BUSINESS

### By-laws

Discussion. A shared [google document](#) is created and open for edits. Would need to vote/adopt during the May meeting (ByLaws are essential for the organization). There is also a [Board Responsibilities](#) document that was drafted – this is less formal and to have a clear understanding on who is responsible for what tasks, this can be changed without formal approval and adjusted depending on number of board members, availability and general vision of the board.

### 501c3 Application

Discussion. Given the small scale (under 50K) and no employees, we qualify for a [1023-EZ](#). It is a simple application and will **cost is around \$275**

A draft of the application is in the “LEGAL” folder. Can proceed now, can wait until summer – will likely get approved sometime in fall if submitted now. Benefits of being 501c3 would include accepting tax-deductible donations, applying for grants, free Canva app & other discounted apps for school non-profits, clear structure and transparency. More responsibility and structure.

**For tax purposes:** if do nothing – will need to file Form 1120 (U.S. Corporation Income Tax Return). The deadline is April 15 every year.

If we file for non-profit & get approved, then our filing requirements are much simpler, we will file Form 990-N (e-Postcard) annually and it will be due May 15 each year. This is a very short online filing.

do we want to look into any giveaways for kids in attendance? Can do rubber bracelets, stickers, face painting, glow sticks, etc.

## VEO Camera - Cost Sharing & Management
