Author should explain the most important finding in the case that is unusual or remarkable. Explain the mechanism/pathophysiology of injury with adequate basis or following guideline (using diagram if the author would like to).

Additional information in the article can be presented in the form of figures and tables. The writing of the table uses the format of row border, font 11 and space 1. The delivery of the tabel must be mentioned in the body text paragraph. Examples of tabular writing can be seen in Table 1.

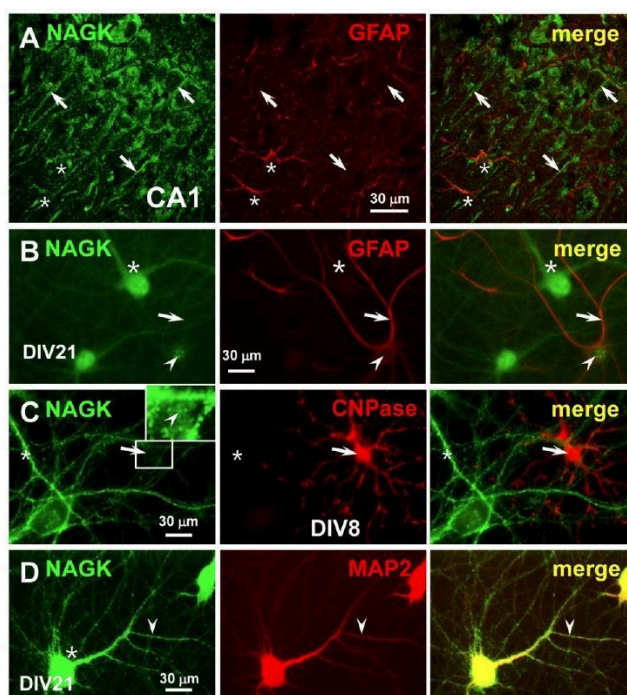


Figure 1. Elevated expression of NAGK in neurons [1]
