Wake Med North Exhibition Info- 2025

Requirements

- Must be a WFGA participating artist.
- WFGA artists are displaying art at the invitation of Wake Med North. We are very appreciative of their hospitality and expect all artists to conduct themselves professionally.
- All art must be suitable for viewing in a public area. WFGA and/or Wake Med North reserve the right to refuse any artwork. Wake Med North administration has final review of artist submissions. Note: No artwork containing or suggestive of nudity will be accepted.
- Artists must adhere to current Wake Med health / masking policies.
- Paintings must have wire backing to hang correctly and safely. No exceptions. Please tape over the wire ends ...cut wires can be very sharp. Please use "D"ring hangers and not eye screws to secure wires to art. Please ask for assistance before installation if you have any questions.
- Works must be large enough to have wires that are a minimum of 10" in length to order to properly hang on hooks.
- Any works under glass over 24" in any dimension will need to be plexi glass / acrylic.
- Art that is larger than 36" in any dimension, must be pre-approved.
- Art must be professionally finished...either framed or edges painted.
- Work must be original and created entirely by the artist.
- Art will not be installed if it is different styles or medium from what was represented on the application.
- Art installed is expected to stay for the duration of the exhibit. If you need to switch art, please check with WFGA first.
- Artists are expected to keep commitments to install/take down appointments as well as attend receptions.
- Info needed for submission
 - 1) name and artist business name
 - 2) contact info and social media links
 - 3) few sentences describing the work that you will be displaying
 - 4) Title for show; either by theme or medium
 - 5) 5 images of your work that are representational of what you will bring.
 - 6) List 3 preferred months to show

Exhibit Information

- Solo exhibitions for one month duration.
 - 2 artists may partner up for exhibition, however their art must be complementary, and they must be able to meet at the same time for set up/take down.
 - Exhibits are to consist of cohesive or complementary works.
- Artists will be selected by WFGA jury. Artists that have not displayed at Wake Med North will be given priority. The call for artists for the upcoming year is posted in October. Artists may be asked to be on a waiting list.
- The display space is approx. 18' of linear space. There are moveable rods with adjustable bars.

There are 12 rods and 17 hangers. We have had as little as 4 works and as many as 16 in a show. Number of works on display depends on the size, orientation, and aesthetics. Keep in mind this is a gallery wall and not a retail/store space. Please refer to WFGA social media posts or visit the Wake Med Gallery wall to see samples of how art is displayed.

- A WFGA appointed volunteer will help curate the exhibitions. WFGA will be responsible for hanging the art onto the system. Artists are encouraged to share their ideas and visions on exhibit arrangements, however WFGA volunteers will make final decisions.
- Business cards are to be left at the concierge desk.
- There are no tags to be placed with the individual pieces of art. To assist any one asking for more info on any of your work, please leave an inventory list at the concierge desk. In respect for their busy desk, this list should be printed on no larger size than 1/2 letter page. Please include your name, contact info and works titles, short descriptions & prices.
- All sales are to be handled entirely by the artist. The hospital staff or volunteers are not to handle sales or act as a go-between for transactions.
- On day of installation, pull car under carport at entrance of Main Entrance. Unload all the art and then move car to the parking lot.
- Approx 3 weeks prior to your scheduled month to exhibit you will be contacted to schedule an
 installation date. The install is coordinated with the outgoing artist so that the wall is not left
 blank and that there is a WFGA volunteer to be there to help curate your show. All efforts are
 made to make this convenient for everyone and to have the switch completed no later than the
 5th of the Month.

Reception

- "Meet the Artist" Lunch time receptions
- Scheduled on one Thursday (TBA) from 11:30 to 1:00pm
- Set up will be along the gallery wall under your art.
- Hospital will provide 1 6ft tables with cloth. Please bring any table displays needed.
- This is a chance to talk about your work and offer visitors a wider price range of items. (cards, prints, small works, etc). Do not bring grids or floor easels. Artists are not to encroach into foot traffic area. Print bins are fine.
- Artists are expected to be committed to attending. Artists are to confirm their attendance by the time of their art installation.
