**Whereas**; the current #political-parties channel doesn't have any actual information about each party.

Whereas; the current #wiki channel doesn't contain all government positions and is very outdated.

Whereas; the subreddit doesn't have any registration of government positions.

Whereas; Don't having good information of each party and don't having good information of government positions and their occupants could confuse new members.

**Therefore**; The Fucking Best Party declares the creation of The List Act. Yes I'm including the party in the bill.

## Article 1 - Current Government Members List

- §1. The archives commission shall create a third section on the wiki index of the subreddit named "Current Government Members" with a list of every government position and their occupants.
- §1.1. The list must include the President, the Vice President, all executive officers (Attorney General, Chief Archivist, Secretary of State, Secretary of Voter Registration, all non-statutory executive officers, etc), the SBDI Director, all Senators, the Speaker of the Senate, all Supreme Court Justices, the Chief Justice, and the Supervisors.
- §2. The archives commission shall create a new discord channel on the info section called "#current-government" to post a list that includes the detachments of the section §1.1 of this article.
- §2.1. If the wiki bot doesn't work, the Chief Archivist or the List Archivist may directly post the list on the channel.
- §2.2. The creation of the #current-government channel shall be free and not follow the Revised Economy Foundation Act.
- §3. If an election and/or appointment changes the occupants of the listed positions, both current government lists shall be updated.
  - §3.1. The Archives Commission has 24 hours to update the lists.
- §4. The Chief Archivist may appoint a List Archivist as part of the Archives Commission, responsible for updating the list if other archivists cannot.

- §5. If both Chief Archivist and List Archivist do not updates the current government members lists in the established time, and other archivists neither, the Reddit and Discord Supervisors are responsible for updating it.
- §6. EO-130-04 is rejected.

## Article 2 - Political Parties List

- §1. The archives commission shall use the #political-parties channel on the discord to include a list of every political party, their proposals and opinions, and the party leaders.
- §2. The archives commission shall include proposals and opinions of each party in the parties list, based on their politics, members, manifesto, etc.
- §3. Party Leaders may edit their section on the parties list asking the archives commission.
- §4. Parties that didn't have senators or executive officers in charge before 1/10/2024, shall not be included in the parties list.
- §4.1. If one of these parties gets a senator or executive officer in charge after the establishment of this act, their party shall be included in the party list.
- §5. The List Archivist also may edit the parties list.

## Article 3 - List Manipulation

- §1. Party Leaders may file a lawsuit against the Archives Commission for list manipulation in the parties list if they:
  - §1.1. Include fake information about the party.
  - §1.2. The party information is biased.
  - §1.3. The commission refuses to edit their section. (following Article 2 §3)
- §2. Any person may file a lawsuit against the Archives Commission for list manipulation in the current government members list if they:
- §2.1. Include a user as occupant in an office, and the user are not in the office.
  - §2.2. Refuses to include a user based on political reasons.

- §3. If the Archives Commission is guilty of list manipulation, depending on the judge's decision, and following Article 2 §3 of the Statute Law Revision Act, it may result on:
  - §3.1. An economic penalty to the responsible archivist.
  - §3.2. The firing of the responsible archivist.
  - §3.3. An economic penalty to the Archives Commission.
  - §3.4. The firing of the Chief Archivist or the List Archivist.
