October 14, 2020 Board Minutes

The board meeting of the HLV Community School District was held on October 14, 2020, at 5:03 p.m. President Hawkins called the meeting to order.

Roll call resulted in board members Hollopeter, Blomme, Hawkins, and Kolesar being present. Doran was absent, a quorum was declared. Also present was Superintendent Hohensee, Cory Lahndorf, Karla Robison, and Lori McClenathan.

Kolesar read the Mission Statement "Teaching our Youth of Today to be Leaders of Tomorrow". Hawkins then read the President's Statement.

Kolesar motioned to approve the consent agenda items, which included approval of the previous meeting minutes, approval of current bills and additional bills, approval of financial reports, facility use requests, open enrollment request from, resignation from, and employment offers to Jeff Boswell, JH boys Basketball coach and Ben Lahndorf, Assistant Girls Basketball Coach, seconded by Blomme, unanimously adopted.

Hollopeter motioned to approve a Modified Allowable Growth Request and Supplemental Aid for a negative Special Education balance in the amount of -\$133,727.55, seconded by Kolesar, unanimously adopted.

Blomme motioned to approve the first reading of policies 106, 414, 501.9E1, 604.11, 907, and 907.R1, seconded by Hollopeter, unanimously adopted.

Hollopeter motioned to approve the first readings to rescind policies 409.4, 409.5, 409.6, 409.7, 409.8, 414.1, 414.2, 414.3, 414.4, 414.5, 414.6, 414.7, and 414.8 seconded by Blomme, unanimously adopted.

Blomme motioned to approve the first readings of policies 409.1, 409.2, 409.3, 409.3E1, 409.3E2, 409.3R1, 409.3R3, 501.9, and 601.2, seconded by Kolesar, unanimously adopted.

Kolesar motioned to approve the request for Darrin Huber to graduate at semester, seconded by Blomme, unanimously adopted.

There was a discussion on winter sports and Covid related information.

Motion by Kolesar to approve the second reading of policy 409.2E1, seconded by Hollopeter, unanimously adopted.

Hollopeter motioned to approve the second reading of policy 409.2E2, seconded by Kolesar, unanimously adopted.

Under the Superintendent's report, Hohensee presented his October schedule. Review of section 200 will be in December and January. The November board meeting is Wednesday November 11 at 5:00pm. The IASB convention will be held virtual November 18-20. Parent-Teacher conferences will be held virtual, unless someone is in need of a face to face conference, we will accommodate. Thank you to the Boy Scout for their hard work with the food drive. They had donations of 502 pounds of canned food.

Principal Lahndorf reported official day is October 15 for certified enrollment. HLV will host football playoffs Friday October 16 against Colo-Nesco. The volleyball team will play in the gold bracket finals on Thursday October 15 in Belle Plaine and HLV will host first round of regionals October 19. Cross country will also be attending regionals. October 22 is the end of the first quarter. National Honor Society induction will be October 22. Music concerts will be virtual this fall.

Guidance Counselor Robison noted she has met with the seniors to finalize I Have A Plan. NHS will not hold an assembly for Veteran's Day due to Covid. The PBIS store is open and students are working hard to earn tickets.
