The results of the study should be written clearly and concisely. The discussion should describe the importance of the results of the study, not repeat it.

3.1 Writing Format

The size of the paper must match the A4 page size, width: 21cm and height: 29.7cm. Margin limits are set as follows.

- Top = 2cm
- Left = 2cm
- Bottom = 1.5cm
- Right = 1.5cm

Writing articles must be in two-column format with a space of 1.0 between columns, Before and After = 0. Paragraphs must be organized. All paragraphs must be level. That is, both left aligned and right aligned.

3.2 Number of Page

The number of pages of papers submitted is between 6 and 12 pages.

3.3 **Document Letters**

All documents must be in Times New Roman. Other font types can be used if needed for special purposes.

3.4 Title and Author

The title must be in the Regular type 18 pt font. Author's name must be in Regular 11 pt font. Author affiliation must be in Italic 10 pt. Email address must be at 9 pt Regular font.

The title and author must be in a single column format and must be centered. Every beginning of a word in the title must be uppercase except for short words like, "a", "and", "in", "by", "for", "from", "on", "or", and the like.

The author's writings may not indicate the name of the position (for example Supervisor), any academic degree (for example Ph.D) or membership of any professional organization (for example, Senior Member of the IEEE).

So as not to confuse, the family name is written in the last part of each author's name (for example John AK Smith). Each affiliation must include, at a minimum, the name of the company and the name of the city / district in which the author is based (eg. ITB AAS Surakarta).

An e-mail address is required for the corresponding author. Information as the author

of the correspondence is written after the email address, For a maximum reference of the last 5 years.

3.5 Heading Section

There should be no more than 3 levels for headings. All headings must be in the 10pt font. Every word in a heading must be capitalized, except for short words as listed in Part III-B.

- 1) I) Heading Level 1: Heading level 1 must be in Small Caps, located in the middle and use uppercase Roman numeric numbers. For example, see the heading "III. Page Style" of this document. Heading level 1 that cannot use numbering are "Thank You" and "References"
- 2) Heading Level-2: Heading level 2 must be italic, close to the left and numbered using capital letters. For example, see the heading "C. The heading" section above. Heading Level-3:
- 3) 3) Heading level-3 must be spaced, italic, and numbered with Arabic numerals followed by right parentheses. Heading level 3 must end with a colon. The contents of the level 3 section follow the heading titles with the same paragraph. For example, this section begins with heading level 3.

3.6 Chart and Table

Charts and tables must be centered. Large graphs and tables can be stretched on both columns. Any table or figure that covers a width of more than 1 column must be positioned at the top or bottom of the page.

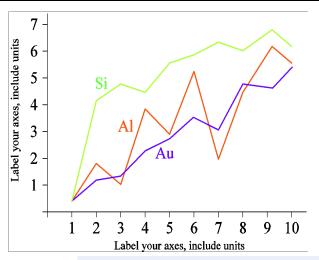


Figure 1. Examples of line graphics using contrasting colors both on a computer screen, and in black and white prints.

Graphics are allowed in color. All colors will be saved on the CDROM. Images may not use dotted patterns because there is a possibility that they cannot be printed in the original. Use contrasting solid coloring both for display on a computer screen, as well as for prints in black and white, as shown in Figure 1.

3.7 Image Caption

3.8 Table Caption

Tables are numbered using uppercase roman numerals. Note the table in the center (centered) and in regular font size of 8 pt with small capital letters. Each word in the table description uses capital letters, except for short words as listed in sections III-B. The table number captions are placed before the linked table, as shown in Table 1.
