## Stand4THEE Saturday Special Zoom, May 10, 2025 with Amanda Ridding Chat Transcript

- Amanda Ridding: I want to talk a bit about what a National Constitution is
- Amanda Ridding: There are many words which may describe an agreement between two or more parties.
- Rebecca Sheppard:

- Amanda Ridding: However there is a specific word which describes an agreement with "the Land" as one party, and a Title. Can anyone tell me the name of that type of agreement
- Virginia: convenant
- robyn: I did a fippa for property tax and they claim we live on crown granted land, aka covenant. Yet this covenant was not stipulated in the title of purchase.
- Rebecca Sheppard: A covenant is a formal agreement or promise, usually included in a contract or deed, to do or not do a particular act. Covenants are particularly relevant in the fields of contract law and property law.
- Amanda Ridding: What they will teach you is that a covenant is between two parties,
- Amanda Ridding: What they fail to admit to you is that one party is the Land itself.
- Amanda Ridding: The Land is given a Title, or legal description.
- Amanda Ridding: In law there are two types of Land Title.
- Amanda Ridding: Private titles would be those held by individual or corporations which come with and include certain rights. In some cases, a charter may include covenants as part of its provisions. For instance, the Covenant of the League of Nations was the charter document that established the League of Nations, outlining the organization's purposes and the obligations of its member state
- Amanda Ridding: If you own your home, you possess the Land Title.
- Amanda Ridding: If you buy a Land Title, you become the registered Title holder making you the and party in this covenant which runs with the Land.
- Amanda Ridding: As the Land Title holder, you assume the care, custody and control of that Land to be worked and used in the Land's best interest.
- Amanda Ridding: The second type of Land Title is the Public Title.
- Amanda Ridding: With this type of Title, as first established by the English Bill of Rights 1689, the Title Holder is the bound custodian of the public Land to manage and maintain, as directed by His master, the Voter.
- Amanda Ridding: Just like a judge of a court, no executive administrative public servant may "move" meaning do something, without either reasonable and probable grounds, or because we told them so.
- Virginia: yes
- Amanda Ridding: Someone asked who decides what is good for the Land
- Amanda Ridding: We the Voters decide what is best for the Land and the people.
- Amanda Ridding: Every Act of legislation, like the Constitution, is a binding covenant, but not with individuals.
- Amanda Ridding: Acts of legislation are bound between the territorial Land for which is was made and either the GG or LG of a province, as the case may be.
- Amanda Ridding: Canada's jurisdiction over Health Care is limited to Quarantine and Marine Hospitals. That's it!
- Elizabeth: Does the fed gov allocate money towards healthcare?

- robyn: The feds gave our municipality and others \$1.5 million to implement the federal agenda for housing, tracking and tracing and drugs treatment
- Amanda Ridding: To see the Federal Governments limited jurisdiction over Health Care may be seen at Section 91 (11) of the BNA
- Amanda Ridding: The universe took away my voice, for now. When I lost my voice, it improved my skills of listening. With my improving skills for listening, coupled with my keen Desire to truly understand "the cause", I took a turn in direction from most everyone else I'm aware of, or know. It led to the knowledge I now share. The knowledge I possess often has a doppelgänger from the knowledge possessed by most others. It's up to everyone which path of knowledge they wish to pursue. But as best as I can tell, the two most often will not reconcile with the other.
- Amanda Ridding: I have 2.5 sisters. One of my sisters has a doppelgänger. Her doppelgänger is our cousin. Being our cousin, our cousin Claire is not a direct relation but an indirect relation. When together their similarities are very present, but one can tell them apart. However, when isolated from the other, in "certain" circumstances, it's very easy to mistake one for the other. - Amanda Ridding: I am not the only one in my family to mistake Claire for my sister. Another of my sisters has also mistaken Claire when she spotted Claire in the airport. My point?
  - o Whenever a person, place, or thing, is taken and seen "out of context" it's easy for your eyes to play tricks on you and your mind. Never forget this. Canada and CANADA may look the same, but they are nothing alike. Stop thinking of them as one in the same.
  - o One last thought...I do not have the documents which were used to register a CANADA on the stock exchange. What I know is I have found no authority of law to allow the registration of a CANADA on the stock exchange.

- Rebecca Sheppard: Canada = proper noun
- Rebecca Sheppard: Government of Canada = proper noun
- Rebecca Sheppard: CANADA = not proper noun
- Nunya: What CANADA is written in all caps?
- Amanda Ridding: ALL CAPS is not a fiction. Fictions are imaginary
- Amanda Ridding: An ALL CAPS name is a very real artificial legal person, or entity, which can otherwise die because it has never breathed life.
- Amanda Ridding: A Title, and Title is bound to a covenant, somewhere established either as Land itself, or an address of Head Office.
- Amanda Ridding: Land has both a Legal Description, primary name, or an address, public name.
- Amanda Ridding: It helps to establish a covenant hierarchy of the relationship of the land custodian in position of Title Holder.
- Amanda Ridding: This is why the principles of estate law to all covenants.

- Amanda Ridding: Anything which is tied to land is a covenant runs with the land.
- Amanda Ridding: An individual's ALL CAPS name is a unique kind of covenant, as it attaches to oneself.

- Amanda Ridding: All registry means is an official record book
- Joel: The all caps name is a legal personality that every possesses. This fact is expressed in article 1 of the Quebec and Quebec civil code "everyone possesses a legal personality"
- Amanda Ridding: The Holed over the registry, aka Registrar, does not possess any ownership rights.
- Amanda Ridding: Do not confuse the ALL CAPS name with your Social Security number
- Rebecca Sheppard: The ALL CAPS name represents our estate, it doesn't die when we do.
- Amanda Ridding: A Registry owns nothing but the information kept there.
- Amanda Ridding: Is insurance not a bond?
- robyn: I wanted to return the SIN they said I cant remove myself from it or disassociate.
  o who said that?
- Amanda Ridding: If insurance is a bond, then does it not stand to reason that it is through our SIN numbers we are all being tied to the BOND market?
- Rebecca Sheppard: An insurance bond is a bond that is designed specifically to protect an individual or organization against financial loss if certain circumstances occur
- Amanda Ridding: Replying to "If insurance is a bo..." Anyone want to disprove this?
- Amanda Ridding: The birth certificate nonsense tying you to current-sea is a doppleganger
- robyn: True but it appears to do the opposite, unless you collect EI or cpp
- Amanda Ridding: This doppelgänger was created by a tactic called syllogism, or other similar tactics.
- Howard Bertram: There are companies that exist to research how many times your SIN has been traded ... 2 years ago I did mine and was traded over 70 times since I was issued my SIN #
- robyn: That is the insurance no?
- Laurie: Yes because it's a social INSURANCE number
- Janine: What is a bond exactly?
- Janine: So if your not registered how do you survive?
- Amanda Ridding: I'm not taking the time to discuss what a bond is. I am not here to educate on the finance market. Not my area of expertise
- Janine: Your BC and SIN
- Janine: Either
- Amanda Ridding: I WANT my BC. I own Land. Without being able to register my Land to my ALL CAPS title, I can not will my Land rights to my children.
- Doug Porter: Who benefits by a SIN / bond trade and how?
- Amanda Ridding: Good fucking question?
- robyn: They pray we die before we collect, they even did a study on the CPP to death ratio here in canada
- Amanda Ridding: Without the authorities to prove my speculation I would say the bankers and or Oligarchys
- Amanda Ridding: They don't care about collateral damage.

- Alexandra: If they're trading us on the stock market can't we come after them for the profits made ?
- Amanda Ridding: The are creating collateral damage to instil fear. Especially if we die without a will.
- Joel: What I've read, but cannot prove, when they kill us off, they get the rest of the funds from the estate as there's no one there to claim it. Hence why wars are so profitable.
- Wayne: If they are not trying to Kill us, they want us Very iLL to profit of us in the bad unstable health care system!
- Amanda Ridding: Fear controls people best
- robyn: Where are our royalties for natural resources and the bond if there is one?
- Janine: The SSN in states.....is that why they found numbers still being used ala well over 100 years old....so oligarchs collecting the money when they are actually dead?
- Mic: Replying to "Killing us would cre..." True. A will can be created like a patent could it not. Create it and mail it to yourself via Date stamp from Canada post
- robyn: Replying to "Killing us would cre..." It can also be done with pen and paper and two witnesses. That is accepted as a will here in BC.
- Amanda Ridding: Without regaining control over our Legislative Houses, followed by our control over the Government of Canada, it is unlikely we can go after the Fraud. We need to regain control.
- Amanda Ridding: Land and Power
- Amanda Ridding: What we need is to stop crowding into cities and start reclaiming space between each of us. Space helps to facilitate peace
- Karin: With social housing they can set up conditions for those who want support in housing
- Virginia: they can print the money so why would they care
- Amanda Ridding: Money is nothing more than a tool to measure power. This is about claiming power and control over both the Land and the people.
- Amanda Ridding: Both Land and people generate power. These people think they are Gods with the right to control all the power.
- robyn: The tofu construction in china is insane, people pay upfront and in full, and before its completed the builders go bankrupt or its made of Styrofoam.
- Amanda Ridding: Each of us are members of the general public.
- Amanda Ridding: Do "generals" not possess all the power?
- Amanda Ridding: Those with "knowledge" can not be controlled because they know their own power.
- Kimberly Woolman: and here the amount of new apartments going up in our town is unbelievable
- Amanda Ridding: My knowledge of law is such, I know my own power!
- Karin: Money is exactly the tool for them to disable our ability to disagree....because they can starve us through money. However, if we have land to live from then money is not as important
- Alexandra: Question about owning land, if you have a mortgage you technically don't own the land you're on right? You're basically leasing it until it's paid in full?
- Alain A (Mékinac): And these appartement are not for Québecquers too expensive 1400\$ a month need add electricity and insurance.
- Wayne: The Provincial Court of Saskatchewan has it's OWN INHERANT Juridiction . I have evidence of this . So WtF is it's Own Inherant Jurisdiction ??
- Alexandra: So I own the land, the mortgage is then to pay for the house on the land?

- Amanda Ridding: There exists no covenant in law to establish the entity known as Prime Minister. If you agree and accept there is no such thing as a Prime Minister, it is your duty to object and deny the existence of a Prime Minister every time someone tries to discuss what the alleged PM is doing next.
- Mic: Yes. Mortgage is a promissory note isn't it?
- Amanda Ridding: A mortgage is a lien
- Amanda Ridding: Two wrongs do not make a right That is all I say when people start to complain about these impersonators.
- Amanda Ridding: Even if they are unlawfully creating money out of thin air, does not justifying one "tripping" a debt. Yes, this fraudulent system is fucking with our economy and creating "inflation" lead by "economists". They manipulate it further with "interest rates"
- Karin: Life insurance face amount used to be \$1000 50 years ago. So people could've be buried and whatever for 1000 and there was something extra for the family...
- Alexandra: So are they pushing apartments / condos on people because you don't own the land then?
- Amanda Ridding: I tried to being a new perspective to law for people to come to understand.
- robyn: My home is paid off, they are creatively finding ways to try and take it in BC, with speculation tax and grants. There exists no covenant in law to establish the entity known as Prime Minister. If you agree and accept there is no such thing as a Prime Minister, it is your duty to object and deny the existence of a Prime Minister every time someone tries to discuss what the alleged PM is doing next. I have, and am working on a plan with Rebecca.
- Janine: Isn't the grand jury push the way to go?
- Amanda Ridding: Step 1 is critical. I need people to start audibly denying the existence of a Prime Minister every chance presented. Just do what they do: KEEP REPEATING IT. (But obviously, try to only repeat truth)
- Amanda Ridding: Replying to "Isn't the grand jury..." I will address this shortly
- Janine: Why don't we?
- Amanda Ridding: Replying to "Without regaining co..." @Mic.Stro. Remember there are arguments to support in my April 29th article
- Amanda Ridding: This starts the ripple effect
- Alain A (Mékinac): In few time it will be impossible to continue to live in a House, insurance, Carbon rules for your house, Municipal TAX increase all this point will eject you from your house it was i Don't one ONE HOUSE
- Karin: It was breaking, I didn't catch it
- Howard Bertram: Taking the narritive is so important!
- Amanda Ridding: What we are going to do includes getting as many Canadians who believe, to the best of his ore her knowledge, to sign and swear an Affidavit that he or she does not recognise or acknowledge a Prime Minister.
- Kimberly Woolman: do not talk about politics
- Amanda Ridding: Biblically speaking, does anyone know who "the Watchers" are?
- Karin: It's difficult to explain. I have a picture in my head, but no words for what is happening. I am not able to explain to anybody. I am sure many people have the same problem
- robyn: The tax court is not a court of equity. Yet as the maxim goes, equity follows the law. So what kind of court is the tax court?

- Effie Milios: Replying to "Biblically speaking,..."No, curious
- Janine: Doesn't every board though have to have a chair? Who will represent the house of Commons?
- Amanda Ridding: Corporate means body
- Janine: So the Speaker of the house?
- Amanda Ridding: Of course the House of Commons is a corporate entity, it's a body!
- Janine: Someone has to lead?
- Janine: I get the MPs
- Karin: Organize
- Amanda Ridding: The Land in a covenant is "the Body".
- Howard Bertram: Watchers in the Bible are a type of angelic being mentioned primarily in the Book of Daniel and the apocryphal Book of Enoch. The term "watcher" refers to angels who are tasked with observing humanity, and they are depicted as both good and rebellious beings.
- Mic.Stro.: So the LAND is like The Body of Mother Earth...
- robyn: Isnt the house where no questions get answered ever? Seems like theatre at this point.
- Amanda Ridding: Those who swear the Affidavit affirming he or she does not believe in the existence of a PM, serves and files a copy, each becomes "a Watcher". And I will want to be provided a copy of each one served.
- Amanda Ridding: In the chat of that live, I responded and said "You gave me an idea girl"
- Janine: Where does Human Rights Tribunal come in? Can they do anything?
- Amanda Ridding: I realised the Affidavit was step 2
- Amanda Ridding: And makes those who serve and file the biblical "watchers".
- Laurie: If affidavit is part 2 what is part 1?
- Amanda Ridding: In law, unless you choose to bind yourself to any agreement, no one may tell you what to do. BUT You must remain mindful not to trespass on any other.
- Janine: Yes I know....grand jury then?
- Amanda Ridding: If these people got the same education that you did, why would they know any better than you?
- Karin: Can the government repeal common law? Wasn't Grand Jury a common law inherited from UK?
- Janine: Was the removal legal?
- robyn: Old courthouses with the two jury boxes necessary to accommodate the 24 jurors of a grand jury can still be seen. [71] The grand jury would evaluate charges and return what was called a "true bill (of indictment)" if the charges were to proceed. [72] or a verdict of nolle prosequi if not. [70] The practice gradually disappeared in Canada over the course of the twentieth century, after being the subject of extended discussions late in the 19th.[70] It was ultimately abolished in 1984 when the Nova Scotia courts formally ended the practice.[69][73]
- Amanda Ridding: I searched for any "authority" in law which provides the authority to convene a grand jury. If someone insist that a "grand jury" is the way to go, demand from that person for the Act and Section which provides the authority to convene a grand jury. If they can not produce the authority, maybe reconsider if this person knows anything about law.
- Amanda Ridding: I have yet to find the authority to convene a grand jury.
- Amanda Ridding: No one has any right if no authority exists to establish a right over another.

- Mic.Stro.: If you don't like something they're doing, stop complaining and come up with a solution.
- Amanda Ridding: Otherwise MIND YOUR OWN BUSINESS
- KA: The thing is alot of these new immigrants don't respect our laws
- Amanda Ridding: If you don't know "our laws" how can you respect them.
- Amanda Ridding: Petitions fail, more often than not, because they bring forward the wrong legal argument.
