Secretary Donald called for nominations for board president in which Director Cooney nominated Director Dabeet. There were no further nominations.

A motion was made by Director Schuur and seconded by Director Phillips that nominations cease and a unanimous vote be cast for Director Dabeet as board president. All ayes; motion carried.

Secretary Donald administered the oath of office for board president to Director Dabeet.

As part of the Board Targets/Goals Report, Superintendent Christopher thanked the community for the renewal of the Revenue Purpose Statement. Mr. Christopher thanked Elysee Kress, Deya Leza and Corry Spies for presenting information at the Iowa Association of School Boards' Annual (IASB) Convention about the Muscatine Resource Navigator Program. Superintendent Christopher recognized Director Phillips and Director Schuur for earning individual achievement awards from IASB in the Annual Board Awards Program.

A motion was made by Director Conard and seconded by Director Phillips to approve the consent agenda as follows:

A motion was made by Director Schuur and seconded by Director Conard to approve the Limited English Proficient (LEP) Instruction Beyond 5 Years - (FY24) The district's administration is authorized to submit a request to the School Budget Review Committee for a modified supplemental amount of \$100,858 related to the English language learning program for students who have exceeded five years of weighting that are included on the Fall 2023 certified enrollment headcount. All ayes; motion carried.

A motion was made by Director Phillips and seconded by Director Conard to approve casting ballots for the Mississippi Bend AEA Board of Directors; Paul Brooks, District No. 8 and Mike Duytshaver, District No. 9. All ayes; motion carried.

Director Tom Anderson reviewed the timeline for financial related board agenda items, the deposit balances, revenues and expenditures, the general fund revenues and expenses and shared a chart depicting the State Supplementary Assistance (Allowable Growth) rate.

The board held a second reading of policies; 900.15 (NEW) Use of Recording Devices on School Property and 900.15 (NEW) Use of Recording Devices on School Property -Administrative Regulations.
