

BOA Summary Action Items 2017 - 2018

May 25, 2017 Conference Call

1. Organizing

The offices of Chairperson, Vice-Chair, Treasurer, and Secretary were vacated at the close of the Annual Conference on May 13, 2017. September 29, 2017 Conference Call

1. Dream Center Lake Elsinore

One new development is in response to an opportunity brought forward by Lake Elsinore Dream Center to purchase the property they are currently leasing. With the Superintendent's support and after careful review, The Management Group Board is prepared to make an offer for purchase of the facility, like we did for our Long Beach Blvd. church, to add to our holdings. The offer is \$1.1M and the current return on the property (including existing tenancy) is about 6%. It should be a solid investment and provide our FMCSC ministry additional presence and support in serving the city and fulfilling their mission. For the purpose of FMC protocol, the Management Group is requesting approval to purchase.

Motion to approve the Management Group to purchase the property in Lake Elsinore. Seconded. Motion carried unanimously.

2. Superintendents Vote

Following the Town Hall meetings on January 18 and 20, Bishop Thomas called for an adjourned sitting of the Annual Conference to vote electronically on the superintendent slate presented to the Annual Conference from the Superintendent Nominating Committee. Voting opened on January 22 and closed on February 2, 2018. Of the 145 votes, 139 were eligible and the slate passed 127 (Yes) to 12 (No) to confirm the nomination of Rev. Charles Latchison, Rev. Glen Prior, and Rev. Fraser Venter. They will commence their superintendent duties at the close of Annual Conference on May 19, 2018.

Motion to approve the electronic vote as presented by the Bishop. Seconded. Motion carried unanimously.

The new superintendent team sent a proposal to create a new standing committee, Kingdom Sponsorship Group, that would oversee church plants that aren't being sponsored by a local church. The committee will include 7 members: Marla Jamieson, Carol Duberowski, Donna Marshall, Moises Bejarano and 3 new superintendents. (The committee can add new members later.) The FMCSC Sponsorship Agreement is the guiding policy they will follow.

Motion passed unanimously.

Safety of Children

Motion: Propose the BOA take action to develop a conference wide policy that addresses the safety of children and elders within the church for the purpose of training FMCSC leaders (lay and clergy) and congregations to protect the mission of FMC legally, financially and morally against abuse.
