Dear parents and guardians,

My name is Alexis Piombino and I am the Director of Special Services in East Hanover. Having a child with an Individualized Education Program (IEP) can feel very overwhelming and I want you to know that we are here to help. The East Hanover Special Services Department offers a full range of related services and programming available on the special education continuum of need. Please understand that no two IEPs are alike. Each program has been individualized to meet the needs of your child and not all students require the same level of programming or related services. Below I would like to introduce you to some key individuals on the Child Study Team and also share some resources that may be helpful as you navigate the special education component of your child's schooling. Key Staff

Case Manager: Your child will be assigned a case manager to oversee their special education programming and evaluations. Most likely, you have been working with this individual throughout the evaluation process. While your child's case manager can change from year to year, we try to keep the same case manager with your child during their time in a specific building. Case managers are your contact for any issues you or your child may experience related to your child's IEP or programming.

Special Education Teachers: This teacher is responsible for providing specialized instruction and implementing the IEP goals and objectives, unless otherwise noted. Special education teachers are your contact for any issues you or your child may experience as it relates to day-to-day classroom instruction.

General Education Teachers: This teacher may or may not be part of your child's program. However, this teacher is responsible for implementing district-approved curriculum. If your child does have a general education teacher, this individual can be contacted for any issues you or your child may experience as it relates to day to day classroom instruction.

Related Service Providers: Related service providers are identified as part of your child's program if your child qualifies for school-based services. This can include occupational, speech and physical therapy in addition to counseling, behavioral support, and other supports as deemed necessary by your child's IEP team.
